September 21, 2010 for use on Sweet Corn and Wheat

Dear Dr. Orr,

The supplemental label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended is acceptable, provided that you comply with the following conditions.

1. Make the following changes to the label.

a. In three places in the label the term "potato and tuber/corn vegetables" occurs. In each case change this to "potato and other tuberous and corn vegetables".

b. In the specific use directions for corn on page 3, change the subsection title from "CORN (Field Corn, Sweet and Hybrid Seed Corn)" to either "CORN (Field, Sweet and Hybrid Seed)" or "CORN (Field Corn, Sweet Corn and Hybrid Seed Corn)".

c. In the specific use directions for corn on page 3, in the "Rate to Use" column in the table change "For Field and Seed Corn Apply:" to "For Field and Hybrid Seed Corn Apply:".

d. In the specific use directions for corn on page 3, immediately following the subsection title "RESTRICTIONS AND OTHER INFORMATION:" add a new line that reads "Field and Hybrid Seed Corn".

e. In the specific use directions for corn on page 3, change the first bulleted item in the "RESTRICTIONS AND OTHER INFORMATION:" section from "Do not apply more than 11.4 fl oz (0.36 lb ai)/A of EVITO™ 480 SC Fungicide per acre per year" to "Do not apply more than 11.4 fl oz (0.36 lb ai)/A of EVITO™ 480 SC Fungicide per acre per year (including from an in-furrow or banded application)."

f. In the specific use directions for "Sweet Corn" in the "RESTRICTIONS AND OTHER INFORMATION:" section on page 3, change the first bulleted item from "Do not apply more than 15.2 fl oz (0.48 lb ai)/A of EVITO™ 480 SC Fungicide per acre per year" to "Do not apply more than 15.2 fl oz (0.48 lb ai)/A of EVITO™ 480 SC Fungicide per acre per year (including from an in-furrow or banded application)."

g. In the specific use directions for corn on page 3, delete the sixth bulleted item ("EVITO 480 SC Fungicide may be used with an adjuvant to increase coverage.") in the "RESTRICTIONS AND OTHER INFORMATION:" section. If you wish to add adjuvant use for field and hybrid seed corn you must submit data showing either that use of an adjuvant will not cause overtolerance residues or else that allow a modification of the corn tolerances (the latter would also require submission of a tolerance petition).

h. In the specific use directions for corn on page 3, add a bulleted item reading "Do not apply EVITO 480 SC Fungicide within 7 days of harvest." to the "Sweet Corn" statements in the "RESTRICTIONS AND OTHER INFORMATION:" section. This statement is in the tolerance petition and was reviewed and not commented on during the HED risk assessment.

i. In the specific use directions for corn on page 3, add a bulleted item reading "Do not apply EVITO 480 SC Fungicide within 23 days of use of stover for feed." to the "Sweet Corn" statements in the "RESTRICTIONS AND OTHER INFORMATION:" section.

j. In the specific use directions for wheat on page 4, to the "RESTRICTIONS AND OTHER INFORMATION:" section add the bulleted statement "Make no more than one application prior to harvest of wheat forage."

k. In the specific use directions for wheat on page 4, in the third bulleted item in the "RESTRICTIONS AND OTHER INFORMATION:" section change "...through chemigation or air." to "...through chemigation or by air."

2. Submit one copy of your final printed labeling before you release it for distribution into channels of trade.

The amended master label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended is acceptable, provided that you comply with the following conditions.

1. Make the following changes to the label.

a. In each of the three individual labels within the master label, in the "FIRST AID" section the first subsection is entitled "IF ON SKIN: OR CLOTHING". Change this to "IF ON SKIN OR CLOTHING:".

b. In the "GENERAL Information" section on page 5 and in the "USE DIRECTIONS FOR SPECIFIC CROPS" section on page 12 is the term "potato and tuber/corm vegetables". In each case change this to "potato and other tuberous and corm vegetables".

c. In the list of crops and crop groups immediately following the section title "AERIAL APPLICATION" on page 7 and after the section title "CHEMIGATION" on page 8, revise by placing a closing parenthesis after "hybrid seed corn," and removing the closing parenthesis after "wheat only."

d. In the in-furrow application rate table on page 13 the leftmost column header reads "fl o." product. Revise to read "fl. oz" product.

e. In the specific use directions for corn on page 14, change the subsection title from "CORN (Field Corn, Sweet and Hybrid Seed Corn)" to either "CORN (Field, Sweet and Hybrid Seed)" or "CORN (Field Corn, Sweet Corn, and Hybrid Seed Corn)".

f. In the specific use directions for corn on page 14, in the "Rate to Use" column in the table change "For Field and Seed Corn Apply:" to "For Field and Hybrid Seed Corn Apply:".

g. In the specific use directions for corn on page 14, immediately following the subsection title "RESTRICTIONS AND OTHER INFORMATION:" add a new line that reads "Field and Hybrid Seed Corn".

h. In the specific use directions for corn on page 14, change the first bulleted item in the "RESTRICTIONS AND OTHER INFORMATION:" section from "Do not apply more than 11.4 fl oz (0.36 lb ai)/A of EVITO™ 480 SC Fungicide per acre per year" to "Do not apply more than 11.4 fl oz (0.36 lb ai)/A of EVITO™ 480 SC Fungicide per acre per year (including from an in-furrow or banded application)."

i. In the specific use directions for "Sweet Corn" in the "RESTRICTIONS AND OTHER INFORMATION:" section on page 14, change the first bulleted item from "Do not apply more than 15.2 fl oz (0.48 lb ai)/A of EVITO™ 480 SC Fungicide per acre per year" to "Do not apply more than 15.2 fl oz (0.48 lb ai)/A of EVITO™ 480 SC Fungicide per acre per year (including from an in-furrow or banded application)."

j. In the specific use directions for corn on page 14, delete the sixth bulleted item ("EVITO 480 SC Fungicide may be used with an adjuvant to increase coverage.") in the "RESTRICTIONS AND OTHER INFORMATION:" section. If you wish to add adjuvant use for field and hybrid seed corn you must submit data showing either that use of an adjuvant will not cause overtolerance residues or else that allow a modification of the corn tolerances (the latter would also require submission of a tolerance petition).

k. In the specific use directions for corn on page 14, add a bulleted item reading "Do not apply EVITO 480 SC Fungicide within 7 days of harvest." to the "Sweet Corn" statements in the "RESTRICTIONS AND OTHER INFORMATION:" section. This statement is in the tolerance petition and was reviewed and not commented on during the HED risk assessment.

l. In the specific use directions for corn on page 14, add a bulleted item reading "Do not apply EVITO 480 SC Fungicide within 23 days of use of stover for feed." to the "Sweet Corn" statements in the "RESTRICTIONS AND OTHER INFORMATION:" section.

m. In the specific use directions for low growing berry on page 16, change the first bulleted item in the "RESTRICTIONS AND OTHER INFORMATION:" section from "Do not apply more than 22.8 fl

oz (0.72 lb ai)/A of EVITO™ 480 SC Fungicide per acre per year" to "Do not apply more than 22.8 fl oz (0.72 lb ai)/A of EVITO™ 480 SC Fungicide per acre per year (including from an in-furrow or banded application)."

n. In the specific use directions for low growing berry on page 16, in the "Disease Control" column in the table change "Shaerotheca" to "Sphaerotheca".

o. In the specific use directions for soybean on page 18, change the first bulleted item in the "RESTRICTIONS AND OTHER INFORMATION:" section from "Do not apply more than 11.4 fl oz (0.36 lb ai)/A of EVITO™ 480 SC Fungicide per acre per year" to "Do not apply more than 11.4 fl oz (0.36 lb ai)/A of EVITO™ 480 SC Fungicide per acre per year (including from an in-furrow or banded application)."

p. In the specific use directions for tuberous and corm vegetables on page 19, delete the fifth bulleted item ("Use of a spreader type surfactant may increase coverage.") in the "RESTRICTIONS AND OTHER INFORMATION:" section. If you wish to add surfactant use for tuberous and corm vegetables you must submit data which either show that the use of a surfactant will not cause overtolerance residues or else that allow a modification of the tuberous and corm vegetables tolerances (the latter would also require submission of a tolerance petition).

q. In the specific use directions for wheat on page 20, to the "RESTRICTIONS AND OTHER INFORMATION:" section add the bulleted statement "Make no more than one application prior to harvest of wheat forage."

r. In the specific use directions for wheat on page 20, in the third bulleted item in the "RESTRICTIONS AND OTHER INFORMATION:" section change "...through chemigation or air." to "...through chemigation or by air."

2. Submit the following studies and/or information within the required timeframes. Further details concerning the required submissions and actions can be found in the scientific reviews and risk assessments.

a. Submit, by no later than September 30, 2011, a satisfactory Immunotoxicity (Guideline Requirement Number 870.7800) study of Fluoxastrobin. Please feel free to contact us about study design prior to commencement of the study.

b. Submit, by no later than 18 months following the date of this letter, two additional acceptable sweet corn field trials reflecting the proposed use pattern, one each from Zones 1 and 5. The additional field trials should include use of an adjuvant.

c. Submit, by no later than 18 months following the date of this letter, two additional acceptable wheat field trials reflecting the proposed use pattern, from Zone 8. The additional field trials should include use of a crop oil concentrate.

Note: All additional field trials should include an adjuvant (sweet corn) or crop oil concentrate(wheat).

d. Submit, by June 30, 2011, an acceptable Tier I seedling emergence (Guideline Requirement Number (GRN) 122-1) (OPPTS 850.4100) study that tests the subject product (EPA Registration No. 66330-64) at the new high use rate for drench use on ornamentals.

e. Submit, by June 30, 2011, an acceptable Tier I vegetative vigor (GRN 122-1) (OPPTS 850.4150) study that tests the subject product (EPA Registration No. 66330-64) at the new high use rate for drench use on ornamentals.

f. Submit, by December 31, 2011, one acute (10-day) spiked sediment toxicity test, as described in the OPPTS 850.1735 and 850.1740 protocols. This study will reduce risk assessment uncertainties in regard to freshwater and estuarine/marine sediment dwelling organisms. Note: the submissions must include one study per each of the referenced guidelines above.

g. Submit, by December 31, 2011, one chronic (28-day) spiked sediment toxicity test, as described in the OPPTS 850.1770;850.1760 or OECD 218 protocols. This study will reduce risk assessment uncertainties in regard to freshwater and estuarine/marine sediment dwelling organisms. Note: This submission requires only one study.

h. Submit, by 18 months from the date of this letter, an acceptable Tier II aquatic plant growth study (OPPTS 850.5400), using HEC 7155, of *Selenastrum capricornutum* that determines the NOAEC or the EC₀₅.

i. For the 96-hour acute study of the toxicity of technical fluoxastrobin to the sheepshead minnow (OPPTS 850.1000)


either upgrade the study to acceptable by submission of documentation on the limit of fluoxastrobin in saltwater under test conditions (documentation as specified in OPPTS Series 850.1000) or else submit a new, acceptable such study to the Agency by 15 months from the date of this letter.

3. Submit one copy of your final printed labeling before you release the product for shipment.

If these conditions are not complied with, the registration may be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

EVITO™ 480 SC Fungicide is a broad-spectrum fungicide for the control of certain diseases in corn (field, sweet and hybrid seed corn), fruiting vegetables and leaf petiole vegetables, listed low growing berries peanuts, potato and tuber/corm vegetables, soybean, and wheat. EVITO™ 480 SC Fungicide works by interfering with respiration in plant-pathogenic fungi, and is a potent inhibitor of spore germination and mycelial growth.

AERIAL APPLICATION

Corn (Field, Sweet and Hybrid Seed Corn, listed Low Growing Berries, Soybean, Tuberous and Corm Vegetables, and Wheat only)

For aerial application a minimum of 5 gallons/A is recommended. Avoid application under conditions when uniform coverage cannot be obtained or when excessive spray drift may occur. When reference is made to disease suppression, suppression can mean either erratic control from good to fair, or consistent control at a level below that obtained with the best commercial disease control products.

SOILBORNE/SEEDLING DISEASE CONTROL

(Only for Corn (field, sweet and hybrid seed corn), Soybean, and Low-growing berry (crop subgroup 13-07G))

EVITO 480 SC Fungicide can provide control of many soilborne diseases if applied early in the growing season. Specific applications for soilborne diseases include in-furrow applications or banded applications applied over the row, either shortly after plant emergence or during herbicide applications or cultivation. These applications will provide control of pre- or post-emergence damping off and diseases that infect plants at the soil-plant interface. The use of either type of application depends on the cultural practices in the region. In some locations, one type of application may provide better disease control than the other, depending on the timing of the disease epidemic. Seedling diseases are generally controlled by in-furrow applications while banded applications are more effective against soilborne diseases that develop later in the season. EVITO™ 480 SC Fungicide works by interfering with respiration in plant-pathogenic fungi, and is a potent inhibitor of spore germination and mycelial growth.

UNDER CERTAIN CONDITIONS CONDUCTIVE TO EXTENDED INFECTION PERIODS, ADDITIONAL FUNGICIDE APPLICATIONS BEYOND THE NUMBER ALLOWED BY THIS LABEL MAY BE NEEDED. UNDER THESE CONDITIONS, USE ANOTHER FUNGICIDE REGISTERED FOR THE CROP/DISEASE.

RESISTANCE MANAGEMENT

The active ingredient in EVITO™ 480 SC Fungicide (fluoaxastrobin) belongs to the strobilurin class of chemistry which exhibits no known cross-resistance to other chemical classes including sterol inhibitors, dicarboximides, benzimidazoles, anilinopyrimidines, or phenylamides. Fluoaxastrobin does exhibit cross-resistance to other QoI fungicides, such as: trifloxystrobin, azoxystrobin, kresoxim-methyl, famoxadone, and fenamidone (Group 11 fungicides). Fungal pathogens are known to develop resistance to products with the same mode of action when used repeatedly. Because resistance development cannot be predicted, the use of this product should conform to resistance management strategies established for the crop and use area.

Such strategies may include rotating and/or tank-mixing with products having different modes of action, or limiting the total number of applications per season. Arysta LifeScience encourages responsible resistance management to ensure effective long-term control of the fungal diseases on this label.

Follow the specific crop recommendations that limit the total number of sprays on a crop and the required alternations with fungicides from other resistance management groups. In situations requiring multiple fungicide sprays, develop season-long spray programs for using Group 11 (QoI-containing) fungicides with the following guidelines.

1. When using a Group 11 fungicide as a solo product, the number of applications should be no more than one third of the total number of fungicide applications per season.
2. In programs in which tank mixes or pre-mixes of a Group 11 fungicide with a fungicide of another Group are utilized, the number of Group 11 fungicide applications should be no more than one half of the total number of fungicide applications per season.

APPLICATION GUIDELINES

Broadcast Ground Sprayers

Thorough coverage is necessary to provide good disease control. Applications using sufficient water volume to provide thorough and uniform coverage generally provide the most effective disease control. For ground application equipment, 10 gallons/A minimum is recommended.

Equip sprayers with nozzles that provide accurate and uniform application. Be certain that nozzles are the same size and uniformly spaced across the boom. Calibrate the sprayer before use. Use a pump with the capacity to: (1) maintain a minimum of 35 psi at nozzles, and (2) provide sufficient agitation in the tank to keep the mixture in suspension (this requires recirculation of 10% of the tank volume per minute). Use jet agitators or a liquid sparge tube for vigorous agitation. Use screens to protect the pump and to prevent nozzles from clogging. Screens placed on the suction side of the pump should be 16-mesh or coarser. Do not place a screen in the recirculation line. Use 50-mesh screens at the nozzles. Check nozzle manufacturer's recommendations. For information on spray equipment and calibration, consult sprayer manufacturer's and/or state recommendations. For specific local directions and spray schedules, consult the current state agricultural experiment station recommendations.

Mixing Procedures

Prepare no more spray mixture than is needed for the immediate operation. Thoroughly clean spray equipment before using this product. Agitation is necessary for proper dispersal of the product. Maintain maximum agitation throughout the spraying operation. Do not let the spray mixture stand overnight in the spray tank. Flush the spray equipment thoroughly following each use and apply the rinsate to a previously treated area.

Add 1/2 of the required amount of water to the mix tank. With the agitator running, add the EVITO™ 480 SC Fungicide to the tank. Continue agitation while adding the remainder of the water. Begin application of the solution after the EVITO™ 480 SC Fungicide has completely and uniformly dispersed into the mix water. Maintain agitation until all of the mixture has been applied.

EVITO 480 SC Fungicide+ Tank-mix Partners

Add 1/2 of the required amount of water to the mix tank. Start the agitator running before adding any tank-mix partners. In general, tank-mix partners should be added in this order: products packaged in water-soluble packaging (see note below), wettable powders, wettable granules, (dry flowables), liquid flowables (such as EVITO 480 SC), liquids, and emulsifiable concentrates. CHEMIGATION

Corn (Field, Sweet and Hybrid Seed Corn, Fruiting Vegetables, Leaf Petiole Vegetables, Tuber and Corm Vegetables, Soybean, and Wheat only)

Apply EVITO™ 480 SC Fungicide only through sprinkler type irrigation systems, including center pivot, microjet, wheel lines, lateral move, side roll, or overhead solid set irrigation systems. Do not apply EVITO™ 480 SC Fungicide through any other type of irrigation system.

DIRECTIONS FOR USE THROUGH SPRINKLER IRRIGATION SYSTEMS

Crop injury, lack of effectiveness, or illegal pesticide residues in the crop can result from non-uniform distribution of treated water.

If you have questions about calibration, you should contact State Extension Service Specialists, equipment manufacturers or other irrigation experts.

SPRAY PREPARATION

Remove scale, pesticide residues, and other foreign matter from the chemical tank and entire injector system. Flush with clean water.

APPLICATION INSTRUCTIONS

First prepare a suspension of EVITO™ 480 SC Fungicide in a mix tank. Fill tank with 1/2 to 3/4 the desired amount of water. Start mechanical or hydraulic agitation. Add the required amount of EVITO™ 480 SC Fungicide and then the remaining volume of water. Then set sprinkler to deliver no more than 0.4 inch of water per acre. Start sprinkler and uniformly inject the suspension of EVITO™ 480 SC Fungicide into the irrigation water line so as to deliver the desired rate per acre. The suspension of EVITO™ 480 SC Fungicide should be injected with a positive displacement pump into the main line ahead of a right angle turn to insure adequate mixing. NOTE: When treatment with EVITO™ 480 SC Fungicide has been completed, further field irrigation over the treated area should be avoided for 24 hours to prevent washing the chemical off the crop.

CHEMIGATION SYSTEMS CONNECTED TO PUBLIC WATER SYSTEMS

1. Do not connect an irrigation system (including greenhouse systems) used for pesticide application to a public water system unless the pesticide label prescribed safety devices for public water systems are in place. Public water system means a system for the provision to the public of piped water for human consumption if such system has at least 15 service connections or regularly serves an average of at least 25 individuals daily at least 60 days out of the year.
2. Chemigation systems connected to public water systems must contain a functional, reduced-pressure zone, back flow preventer (RPZ) or the functional equivalent in the water supply line upstream from the point of pesticide introduction. The pesticide injection pipeline must contain a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down.
5. The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops, or in cases where there is no water pump, when the water pressure decreases to the point where pesticide distribution is adversely affected.
6. Systems must use a metering pump, such as a positive displacement injection pump (e.g., diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.
7. Do not apply when wind speed favors drift beyond the area intended for treatment.

SPECIAL PRECAUTIONS FOR CHEMIGATION THROUGH SPRINKLER IRRIGATION SYSTEMS

1. Maintain continuous agitation in mix tank during mixing and application to assure a uniform suspension.
2. Greater accuracy in calibration and distribution will be achieved by injecting a larger volume of a more dilute solution per unit time.
3. The system must contain a functional check valve, vacuum relief valve, and low pressure drain appropriately located on the irrigation pipeline to prevent water source contamination from backflow.
4. The pesticide injection pipeline must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection pump.
5. The pesticide injection pipeline must also contain a functional, normally closed solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shutdown.
6. The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops.
7. The irrigation line or water pump must include a functional pressure switch which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.
8. Systems must use a metering pump, such as a positive displacement injection pump (e. g., diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.
9. Do not apply when wind speed favors drift beyond the area intended for treatment. If you are unsure of wind conditions, contact your local extension agent.
10. Do not apply when system connections or fittings leak, when nozzles do not provide uniform distribution or when lines containing the product must be dismantled and drained. Crop injury, lack of effectiveness, or illegal pesticide residues in the crop may result from non-uniform distribution of treated water.
11. Allow sufficient time for pesticide to be flushed through all lines and all nozzles before turning off irrigation water. A person knowledgeable of the chemigation system and responsible for its operation, or under supervision of the responsible person, shall shut the system down and make necessary adjustments should the need arise.

SPRAY DRIFT

SENSITIVE AREAS

This pesticide must only be applied when the potential for drift to adjacent sensitive areas (e.g., residential areas, bodies of water, known habitats for threatened or endangered species, non-target crops) is minimal (e.g., when wind is blowing away from the sensitive areas).

Avoiding spray drift at the application site is the responsibility of the applicator. The interaction of many equipment-and-weather-related factors determine the potential for spray drift. The applicator and the grower are responsible for considering all these factors when making decisions.

The following drift management requirements must be followed to avoid off-target drift movement from aerial applications to agricultural field crops. These requirements do not apply to forestry applications, public health uses or to applications using dry formulation.

1. The distance of the outer most nozzles on the boom must not exceed $\frac{3}{4}$ the length of the wingspan or rotor.
2. Nozzles must always point backward parallel with the air stream and never be pointed downwards more than 45 degrees.

Where states have more stringent regulations, they should be observed. The applicator should be familiar with and take into account the information covered in the *Aerial Drift Reduction Advisory Information*.

AERIAL DRIFT REDUCTION ADVISORY

This section is advisory in nature and does not supersede the mandatory label requirements.

INFORMATION ON DROPLET SIZE

The most effective way to reduce drift potential is to apply large droplets. The best drift management strategy is to apply the largest droplets that provide sufficient coverage and control. Applying larger droplets reduces drift potential, but will not prevent drift if applications are made improperly, or under unfavorable environmental conditions (see Wind, Temperature and Humidity, and Temperature Inversions below).

CONTROLLING DROPLET SIZE

- Volume - Use high flow rate nozzles to apply the highest practical spray volume. Nozzles with higher rated flows produce larger droplets.
- Pressure - Do not exceed the nozzle manufacturer's recommended pressures. For many nozzle types lower pressure produces larger droplets. When higher flow rates are needed, use higher flow rate nozzles instead of increasing pressure.
- Number of nozzles - Use the minimum number of nozzles that provide uniform coverage.
- Nozzle Orientation - Orienting nozzles so that the spray is released parallel to the airstream produces larger droplets than other orientations and is the recommended practice. Significant deflection from horizontal will reduce droplet size and increase drift potential.
- Nozzle Type - Use a nozzle type that is designed for the intended application. With most nozzle types, narrower spray angles produce larger droplets. Consider using low-drift nozzles. Solid stream nozzles oriented straight back produce the largest droplets and the lowest drift.

BOOM LENGTH

For some use patterns, reducing the effective boom length to less than $\frac{3}{4}$ of the wingspan or rotor length may further reduce drift without reducing swath width.

APPLICATION HEIGHT

Applications should not be made at a height greater than 10 feet above the top of the target plants unless a greater height is required for aircraft safety. Making applications at the lowest height that is safe reduces exposure of droplets to evaporation and wind.

SWATH ADJUSTMENT

When applications are made with a crosswind, the swath will be displaced downwind. Therefore, on the up and downwind edges of the field, the applicator should compensate for this displacement by adjusting the path of the aircraft upwind. Swath adjustment distance should increase, with increasing drift potential (higher wind, smaller drops, etc.)

WIND

Drift potential is lowest between wind speeds of 2 - 10 mph. However, many factors, including droplet size and equipment type determine drift potential at any given speed. Application should be avoided below 2 mph due to variable wind direction and high inversion potential.

NOTE: Local terrain can influence wind patterns. Every applicator should be familiar with local wind patterns and how they affect spray drift.

TEMPERATURE AND HUMIDITY

When making applications in low relative humidity, set up equipment to produce larger droplets to compensate for evaporation. Droplet evaporation is most severe when conditions are both hot and dry.

TEMPERATURE INVERSIONS

Applications should not occur during a temperature inversion because drift potential is high. Temperature inversions restrict vertical air mixing, which causes small suspended droplets to remain in a concentrated cloud. This cloud can move in unpredictable directions due to the light variable winds common during inversions. Temperature inversions are characterized by increasing temperatures with altitude and are common on nights with limited cloud cover and light to no wind. They begin to form as the sun sets and often continue into the morning. Their

presence can be indicated by ground fog; however, if fog is not present, inversions can also be identified by the movement of smoke from a ground source or an aircraft smoke generator. Smoke that layers and moves laterally in a concentrated cloud (under low wind conditions) indicates an inversion, while smoke that moves upward and rapidly dissipates indicates good vertical air mixing.

USE DIRECTIONS FOR SPECIFIC CROPS

EVITO 480 SC Fungicide provides control or suppression of several important diseases of corn (field, sweet and hybrid seed corn), fruiting vegetables and leaf petiole vegetables, listed low growing berries peanuts, potato and tuber/corn vegetables, soybean, and wheat. When reference is made to disease suppression, suppression can mean either erratic control from good to fair, or consistent control at a level below that obtained with the best commercial disease control products.

ROTATIONAL RESTRICTIONS

Treated areas may be replanted immediately following harvest with any crop listed on this label. In addition, areas may be replanted with root vegetables subgroup (e.g. carrot, radish, sugarbeet, turnips), bulb vegetables (e.g. onion and garlic), leafy greens subgroup (e.g. lettuce, spinach), brassica vegetables (e.g. broccoli, cauliflower, cabbage, mustard greens), alfalfa, cotton, legume vegetables (dry and succulent peas and beans), cereal grains, and forage grasses following a 30-day plant back interval. For all other crops, do not plant back within one year of the last field application.

SOILBORNE/SEEDLING DISEASE CONTROL

(Only for Corn (field, sweet and hybrid seed corn), Soybean, and Low-growing berry (crop subgroup 13-07G))

EVITO 480 SC Fungicide can provide control of many soilborne diseases if applied early in the growing season. Specific applications for soilborne diseases include in-furrow applications or banded applications applied over the row, either shortly after plant emergence or during herbicide applications or cultivation. These applications will provide control of pre- or post-emergence damping off and diseases that infect plants at the soil-plant interface. The use of either type of application depends on the cultural practices in the region. In some locations, one type of application may provide better disease control than the other, depending on the timing of the disease epidemic. Seedling diseases are generally controlled by in-furrow applications while banded applications are more effective against soilborne diseases that develop later in the season. Consult your local expert to get some guidance regarding application type.

For banded applications, apply EVITO 480 SC Fungicide prior to infection as a directed spray to the soil, using single or multiple nozzles, adjusted to provide thorough coverage of the lower stems and the soil surface surrounding the plants. Band width should be limited to 7 inches or less. Apply EVITO 480 SC Fungicide at a rate of 0.16-0.24 fl oz product/1,000 row feet. (These applications come into contact with the foliage and are counted as foliar applications when considering resistance management. They may be applied during cultivation or hilling operations to provide soil incorporation.

For in-furrow applications, apply EVITO 480 SC Fungicide as an in-furrow spray in 3-20 gallons of water at planting. Mount the spray nozzle so the spray is directed into the furrow just before the seed is covered. Use the higher rate when the weather conditions are expected to be conducive for disease development, if the field has a history of *Pythium* problems, or if minimum/low till programs are in place.

IN-FURROW APPLICATION RATES

Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

CONTAINER HANDLING

Nonrefillable container. Do not reuse or refill this container. Offer for recycling, if available, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows, empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container $\frac{1}{4}$ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.

GENERAL INFORMATION

DISARM™ 480 SC Fungicide is a broad-spectrum xylem systemic fungicide for the control of certain diseases in turf and ornamentals. DISARM 480 SC works by interfering with respiration in plant-pathogenic fungi, and is a potent inhibitor of spore germination and mycelial growth. The active ingredient, fluoxastrobin, moves rapidly into green tissue via translaminar and xylem movement and is rainfast in as little as fifteen minutes after application. Roots of plants also take up the active ingredient where it is translocated throughout the xylem of plants to provide internal inhibition of fungal growth and protect the plant from new infections. The broad spectrum of activity of DISARM 480 SC makes it an excellent choice as the foundation fungicide for turf and ornamental disease management programs. Other labeled fungicides can be used in tank mixture or alternated with DISARM 480 SC to cover all the major fungal diseases that attack most, if not all, major turfgrass and ornamental species.

UNDER CERTAIN CONDITIONS CONDUCIVE TO EXTENDED INFECTION PERIODS, ADDITIONAL FUNGICIDE APPLICATIONS BEYOND THE NUMBER ALLOWED BY THIS LABEL MAY BE NEEDED. UNDER THESE CONDITIONS, USE ANOTHER FUNGICIDE REGISTERED FOR THE DISEASE.

RESISTANCE MANAGEMENT

The active ingredient in DISARM 480 SC (fluoxastrobin) belongs to the strobilurin class of chemistry which exhibits no known cross-resistance to other chemical classes including sterol inhibitors, dicarboximides, benzimidazoles, anilinopyrimidines, or phenylamides. Fluoxastrobin exhibits cross-resistance to other QoI fungicides, such as: trifloxystrobin, azoxystrobin, and

kresoxim-methyl (Group 11 fungicides). Certain fungal pathogens are known to develop resistance to products with the same mode of action when used repeatedly. Because resistance development cannot be predicted, the use of this product should conform to resistance management strategies established for turf and ornamentals. Such strategies may include rotating and/or tank-mixing with products having different modes of action, or limiting the total number of applications per season. Arysta LifeScience encourages responsible resistance management to ensure effective long-term control of the fungal diseases on this label.

Follow specific recommendations that limit the total number of sprays on turf and ornamentals and the required alternations with fungicides from other resistance management groups. In situations requiring multiple fungicide sprays, develop season-long spray programs for using Group 11 (QoI-containing) fungicides with the following guidelines. Turf pathogens that incite Dollar Spot, Gray Leaf Spot, Anthracnose, and Pythium Blight are known to have the capacity to develop resistant populations with the repeated use of a single fungicide or a single class of fungicide chemistry. Certain fungal pathogens of ornamentals also have the capacity to become resistant to single site inhibitor fungicides. In particular, the pathogens that incite Downy Mildew, Powdery Mildew and Rust diseases of ornamentals are known to have the capacity to develop resistance to single site inhibitors.

1. When using a Group 11 fungicide alone, the number of applications made for control of at risk diseases should be no more than one third of the total number of fungicide applications per season.
2. In programs where tank mixes or pre-mixes of a Group 11 fungicide with a fungicide of another Group are utilized, the number of Group 11 fungicide applications made for control of at risk diseases should be no more than one half of the total number of fungicide applications per season.
3. In programs where applications of Group 11 fungicides are made with both solo products and mixtures, the number of Group 11 fungicide applications made for control of at risk diseases should be no more than one half of the total number of fungicide applications per season.

APPLICATION GUIDELINES
Broadcast Ground Sprayers

Thorough coverage is necessary to provide good disease control. Applications using sufficient water volume to provide thorough and uniform coverage provide the most effective disease control.

Equip sprayers with nozzles that provide accurate and uniform application. Be certain that nozzles are the same size and uniformly spaced across the boom. Calibrate the sprayer before use. Use a pump with the capacity to: (1) maintain a minimum of 35 psi at nozzles, and (2) provide sufficient agitation in the tank to keep the mixture in suspension (this requires recirculation of 10% of the tank volume per minute). Use jet agitators or a liquid sparge tube for vigorous agitation. Use screens to protect the pump and to prevent nozzles from clogging. Screens placed on the suction side of the pump should be 16-mesh or coarser. Do not place a screen in the recirculation line. Use 50-mesh screens at the nozzles. Check nozzle manufacturer's recommendations. For information on spray equipment and calibration, consult

sprayer manufacturer's and/or state recommendations. For specific local directions and spray schedules, consult the current state agricultural experiment station recommendations.

Mixing Procedures

Prepare no more spray mixture than is needed for the immediate operation. Thoroughly clean spray equipment before using this product. Agitation is necessary for proper dispersal of the product. Maintain maximum agitation throughout the spraying operation. Do not let the spray mixture stand overnight in the spray tank. Flush the spray equipment thoroughly following each use and apply the rinsate to a previously treated area.

DISARM 480 SC Alone

Add 1/2 of the required amount of water to the mix tank. With the agitator running, add the DISARM 480 SC to the tank. Continue agitation while adding the remainder of the water. Begin application of the solution after the DISARM 480 SC has completely and uniformly dispersed into the mix water. Maintain agitation until all of the mixture has been applied.

DISARM 480 SC + Tank-mix Partners

Add 1/2 of the required amount of water to the mix tank. Start the agitator running before adding any tank-mix partners. In general, tank-mix partners should be added in this order: products packaged in water-soluble packaging (see note below), wettable powders, wettable granules, (dry flowables), liquid flowables (such as DISARM 480 SC), liquids, and emulsifiable concentrates. Always allow each tank-mix partner to become fully and uniformly dispersed before adding the next product. Provide sufficient agitation while adding the remainder of the water. Maintain agitation until all of the mixture has been applied.

Note: When using DISARM 480 SC in tank-mixtures, all products in water-soluble packaging should be added to the tank before any other tank-mix partner, including DISARM 480 SC. Allow the water-soluble packaging to completely dissolve and the product(s) to completely disperse before adding any other tank-mix partner to the tank.

If using DISARM 480 SC in a tank-mixture, observe all directions for use, sites, use rates, dilution ratios, precautions, and limitations, which appear on the tank-mix product label. No label dosage rate may be exceeded, and the most restrictive label precautions and limitations must be followed. This product must not be mixed with any product that prohibits such mixing. Tank-mixtures or application of other products referenced on this label are permitted only in those states in which the referenced products are registered.

DISARM 480 SC is compatible with most pesticides, plant growth regulators and foliar nutrient products. However, the physical compatibility of DISARM 480 SC with tank-mix partners should be tested before use. To determine the physical compatibility of DISARM 480 SC with other products, use a jar test, as described below.

Jar Test Procedure: Using a quart jar, add the proportionate amounts of the products to 1/2 qt. of water. Add wettable powders and water dispersible granular products first, then liquid flowables, and emulsifiable concentrates last. After thoroughly mixing, add the remaining 1/2 qt of water, shake and let stand for at least 5 minutes. If the combination remains mixed or can be remixed readily, it is physically compatible. Once compatibility has been proven, use the same procedure for adding required ingredients to the spray tank.

The safety of all potential tank-mixes including additives and other pesticides on turf and ornamentals has not been tested. Before applying any tank-mixture not specifically recommended on this label, the safety to turf and ornamentals should be confirmed. To test for turf and ornamental safety, apply DISARM 480 SC in a small area and in accordance with label instructions. Observe plants over a period of time for the appearance of phytotoxicity symptoms.

DIRECTIONS FOR USE THROUGH SPRINKLER IRRIGATION SYSTEMS

Apply this product only through overhead sprinkler irrigation systems including center pivot, microjet, wheel lines, lateral move, side roll, or overhead solid set irrigation systems. Do not apply this product through any other type of irrigation system. Reduced effectiveness in turf, can result from non-uniform distribution of the treated irrigation water.

If you have questions about calibration, you should contact State Extension Service Specialists, equipment manufacturers or other irrigation experts.

SPRAY PREPARATION

Remove scale, pesticide residues, and other foreign matter from the chemical tank and entire injector system. Flush with clean water.

APPLICATION INSTRUCTIONS

First prepare a suspension of DISARM 480 SC in a mix tank. Fill tank with 1/2 to 3/4 the desired amount of water. Start mechanical or hydraulic agitation. Add the required amount of DISARM 480 SC and then the remaining volume of water. Then set sprinkler to deliver no more than 0.4 inch of water per acre. Start sprinkler and uniformly inject the suspension of DISARM 480 SC into the irrigation water line to deliver the desired rate per acre. The suspension of DISARM 480 SC should be injected with a positive displacement pump into the main line ahead of a right angle turn to insure adequate mixing. If you should have any other questions about calibration, you should contact State Extension Service specialists, equipment manufacturers or other experts.

NOTE: When treatment with DISARM 480 SC has been completed, further field irrigation over the treated area should be avoided for 24 hours to prevent washing the chemical off the turf.

CHEMIGATION SYSTEMS CONNECTED TO PUBLIC WATER SYSTEMS

1. Do not connect an irrigation system (including greenhouse systems) used for pesticide application to a public water system unless the pesticide label prescribed safety devices for public water systems are in place. Public water system means a system for the provision to the public of piped water for human consumption if such system has at least 15 service connections or regularly serves an average of at least 25 individuals daily at least 60 days out of the year.
2. Chemigation systems connected to public water systems must contain a functional, reduced-pressure zone, back flow preventer (RPZ) or the functional equivalent in the water supply line upstream from the point of pesticide introduction. As an option to the RPZ, the water from the public water system should be discharged into a reservoir tank prior to pesticide introduction. There shall be a complete physical break (air gap) between the flow outlet end of the fill pipe and the top or overflow rim of the reservoir tank of at least twice the inside diameter of the fill pipe.

3. The pesticide injection pipeline must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection.
4. The pesticide injection pipeline must contain a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down.
5. The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops, or in cases where there is no water pump, when the water pressure decreases to the point where pesticide distribution is adversely affected.
6. Systems must use a metering pump, such as a positive displacement injection pump (e.g., diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.
7. Do not apply when wind speed favors drift beyond the area intended for treatment.

SPECIAL PRECAUTIONS FOR CHEMIGATION THROUGH SPRINKLER IRRIGATION SYSTEMS

1. Maintain continuous agitation in mix tank during mixing and application to assure a uniform suspension.
2. Greater accuracy in calibration and distribution will be achieved by injecting a larger volume of a more dilute solution per unit time.
3. The system must contain a functional check valve, vacuum relief valve, and low pressure drain appropriately located on the irrigation pipeline to prevent water source contamination from backflow.
4. The pesticide injection pipeline must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection pump.
5. The pesticide injection pipeline must also contain a functional, normally closed solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shutdown.
6. The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops.
7. The irrigation line or water pump must include a functional pressure switch which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.
8. Systems must use a metering pump, such as a positive displacement injection pump (e. g., diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.
9. Do not apply when wind speed favors drift beyond the area intended for treatment. If you are unsure of wind conditions, contact your local extension agent.
10. Do not apply when system connections or fittings leak, when nozzles do not provide uniform distribution or when lines containing the product must be dismantled and drained. Reduced effectiveness may result from non-uniform distribution of treated water.

11. Allow sufficient time for pesticide to be flushed through all lines and all nozzles before turning off irrigation water. A person knowledgeable of the chemigation system and responsible for its operation, or under supervision of the responsible person, shall shut the system down and make necessary adjustments should the need arise.
12. Do not connect an irrigation system used for pesticide application to a public water system unless the pesticide label-prescribed safety devices for public water systems are in place.

SPRAY DRIFT

SENSITIVE AREAS

This pesticide must only be applied when the potential for drift to adjacent sensitive areas (e.g., residential areas, bodies of water, known habitats for threatened or endangered species, non-target crops) is minimal (e.g., when wind is blowing away from the sensitive areas).

Avoiding spray drift at the application site is the responsibility of the applicator. The interaction of many equipment-and-weather-related factors determine the potential for spray drift. The applicator and the grower are responsible for considering all these factors when making decisions.

USE DIRECTIONS FOR TURF

DISARM 480 SC provides control of many important diseases in turf. DISARM 480 SC should be used in conjunction with cultural practices that promote healthy, vigorous turf. These practices include nutrient management, thatch management, water management and judicious use of other fungicides and cultural practices.

For use in the establishment of turfgrass from seed or in overseeding of dormant turfgrass:

DISARM 480 SC may be used for control of certain turfgrass diseases associated with turfgrass establishment from seed. DISARM 480 SC may also be used during overseeding of dormant turfgrass.

DISARM 480 SC may be safely applied before or after seeding or at seedling germination and emergence to ryegrass, bentgrass, bluegrass, fescue, and other turfgrasses. Optimum application timing for control of seedling diseases is just prior to, during or just after seeding.

Rate Ranges: Use the shorter specified application interval and/or the higher specified rate when prolonged favorable disease conditions exist.

DIRECTIONS FOR APPLICATION TO ORNAMENTALS

DISARM 480 SC is recommended for control of certain pathogens causing foliar, root and stem diseases of ornamentals. Applications can be made to plants growing in containers, benches, flats, plugs and beds in greenhouses, shadehouses, outdoor nurseries, field plantings, retail nurseries, interiorscapes, residential, public and commercial landscape areas.

Foliar Application: Apply DISARM 480 SC in sufficient water to ensure complete coverage of the target plant. Apply in enough water to wet the leaf surfaces to the point of drip. Repeat applications at specified intervals as long as conditions for disease are favorable. Applications should begin prior to disease development and continue throughout the season at specified intervals. DISARM 480 SC is most effective when applied preventively before disease is widespread.

Apply DISARM 480 SC at use rates of 1 – 4 oz/100 gallons every 7 – 28 days. The addition of a non-ionic surfactant at the recommended use rates may enhance coverage on hard-to-wet plant foliage. Under light to moderate disease pressure, use the lower rates (1-2 oz/100 gallons) on a 7 – 14 day interval or the higher rates (3 – 4 oz/100 gallons) on a 14 – 28 day interval. Under environmental conditions which promote severe disease development, use the higher rates (3 – 4 oz/100 gallons) on a 7 – 14 day interval. Use a spray volume of 100 – 400 gallons of solution per acre, depending on the size of the plants.

Arysta LifeScience North America, LLC recommends the use of a Chemical Producers and Distributors Association certified adjuvant.

Drench, Crown and Surface Spray Application: DISARM 480 SC may be applied to control soilborne, seedling, and crown diseases of production ornamentals (greenhouse, shadehouse, container grown and field grown) as a preventative, drench, crown or surface spray treatment

prior to infection. Good coverage of the pre-infection area (root zone, root ball, crown, etc.) is necessary for satisfactory control. Make applications prior to infection as healthy roots are necessary to optimize product uptake systemic translocation and disease protection.

DISARM 480 SC may be applied as drench to container grown ornamentals using 0.15 – 0.6 fl oz/100 gallons of water. Thoroughly wet the root zone of the plants with the solution using up to 1 – 2 pts per sq. ft. of surface area. If a drench application is not feasible, use 0.4 – 1.6 fl oz/1,000 sq. ft. of growing area in sufficient water to provide uniform coverage and follow with enough irrigation to completely wet the root zone of the plants. Use of the higher rate drench is limited to one application per year.

Restrictions: Do not apply more than 2.2 lbs. a.i. per acre per year.
