- 3. Submit the following data within two years of the date of this Notice:
- a. Submit an aerobic aquatic metabolism study (§162-4).
- b. Submit a small-scale prospective groundwater monitoring study (§166-1). The submission of a protocol prior to study initiation is recommended.
- 4. Please note that, as a condition of the original registrations of products containing clothianidin as an active ingredient, additional ecological effects data were required. These data are also required to support all subsequently registered products containing clothianidin as an active ingredient. In the event that acceptable ecological effects data are not submitted to satisfy these conditions, you will be required to submit such data, or this registration will be subject to cancellation under FIFRA sec. 6(e).

GENERAL INFORMATION

ARENA 0.5 G is an insect control product, for broad spectrum control of White grubs (Japanese beetle, Green June beetle, European chafer, Northern masked chafer, Southern masked chafer, and Oriental beetle), Billbugs, Sod webworms, Asiatic garden beetles, Chinch bugs, Mole crickets and Cutworms. When applied on turfgrass as directed, ARENA 0.5 G provides excellent and long residual control of the above listed insects.

PLANT TOLERANCE

Neither the manufacturer nor the seller has determined whether or not ARENA 0.5 G can be used safely on all cultivars of plants listed on the label. ARENA 0.5 G has been tested on many cultivars with no phytotoxicity observed at label rates. Since all plant species and their varieties and cultivars have not been tested for tolerance, it is recommended that a small area or number of plants be treated to make certain that no phytotoxicity occurs, prior to any large scale application to plants. The end user assumes all risks arising from application of ARENA 0.5 G in a manner inconsistent with its labeling.

DIRECTIONS FOR USE

AGRICULTURAL USE REQUIREMENTS

APPLICATION TO TURFGRASS

Use ARENA 0.5 G as directed on grass grown in industrial, commercial and residual landscapes such as, but not limited to golf courses, home lawns, airports, cemeteries, parks, playgrounds, athletic fields and commercial sod farms.

ARENA 0.5 G has sufficient residual activity to provide high levels of control when applications are made preceding or during the egg laying activity of the target pests. Base the need for application on historical monitoring of the site, previous records or experiences, current season adult trapping or other methods. Optimum control will be achieved when applications are made prior to egg hatch of target pests, followed by sufficient irrigation or rainfall to move the active ingredient through the hatch.

Avoid mowing turfgrass until after irrigation or rainfall has occurred so that uniformity of application will not be affected.

APPLICATION EQUIPMENT

Apply ARENA 0.5 G uniformly over the area being treated with normally used granular application equipment. Use either drop-type and rotary-type spreaders to apply ARENA 0.5 G. Avoid the use of spreaders which would apply the material in narrow, concentrated bands. Calibrate application equipment prior to use according to the manufacturer's directions. Check frequently to be sure equipment is working properly and distributing granules uniformly and accurately.

- Consult your local State Agricultural Experiment Station or State Extension Turf Specialists for more specific information regarding timing of application.
- 2. Do not apply more than a total of 80 lbs of ARENA 0.5 G (0.4 lbs active ingredient clothianidin) per acre pre season.
- 3. If the maximum season limit of clothianidin as mentioned above has been applied and pest populations require additional treatments, use another registered pesticide that is not in the neonicotinoid class of chemistry.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE: Store in a dry place away from excessive heat. Do not store near food or feed. Store in original container only. To close package, replace and tighten cap to form an airtight seal.
