Subject: Label Notification for Pesticide Registration Notice 2007-4; Update Company Name per Pesticide Registration Notice 98-10 (EPA Registration Number 66330-54)

Dear Mr. Washburn,

The Agency is in receipt of your Application for Pesticide Notification under Pesticide Registration Notices (PRN) 98-10 and 2007-4 dated February 3, 2009 for the product Captan Technical (EPA Registration Number 66330-54). The Registration Division (RD) has conducted its review of this request for its applicability under PRNs 98-10 and 2007-4 and finds that the label changes requested fall within the scope of PRNs 98-10 and 2007-4. The label submitted with the application has been stamped "Notification" and will be placed in our records. Please note that there is a typographical error in the second sentence of the instructions for "Drums" in the Container Disposal section of the label- the sentence should read "Refill this container with pesticide only." This error should be corrected before final printing of the label.

Please be reminded that 40 CFR Part 156.140(a)(4) requires that a batch code, lot number, or other code identifying the batch of the pesticide distributed and sold be placed on nonrefillable containers. The code may appear either on the label (and can be added by nonnotification/PR Notice 98-10) or durably marked on the container itself.
