

NOTE TO PHYSICIAN

Antidote: administer atropine sulfate in large doses. TWO to FOUR mg. intravenously or intramuscularly as soon as cyanosis is overcome. Repeat at 5 or 10-minute intervals until signs of atropinization appear. 2-PAM chloride is a pharmacologic antidote and may be administered as an adjunct to, but not a substitute for, atropine, which is a symptomatic and often life-saving antidote. DO NOT GIVE MORPHINE OR TRANQUILIZERS. Dimethoate is a cholinesterase inhibitor affecting the central and peripheral nervous systems and producing cardiac and respiratory depression. At first sign of pulmonary edema, the patient should be given supplemental oxygen and treated symptomatically. Continued absorption of the poison may occur and relapse have been reported after initial improvement; VERY CLOSE SUPERVISION OF THE PATIENT IS INDICATED FOR AT LEAST 48 HOURS.
