#### NOTE TO PHYSICIAN

Chlorpyrifos is a reversible cholinesterase inhibitor. Atropine Sulfate is antidotal. Start treatment by giving 2 mg atropine by injection after cyanosis is overcome and repeat atropine at 0.4 to 4 mg every 15 minutes until atropinization is achieved (tachycardia, flushing, dry mouth and mydriasis). Oximes such as 2-PAM/protopam are also antidotal, but only in conjunction with atropine. Observe to insure symptoms do not recur as atropinization wears off. Morphine, theophyllins, phenothiazines and reserpine are probably contraindicated. This product may pose an aspiration pneumonia hazard. Contains petroleum distillate. Consideration should be given to gastric lavage with endotracheal tube in place. Treatment is controlled removal of exposure followed by antidotal, symptomatic and supportive care.
