3. Submit two copies of a final printed label within 30 days from the date of this notice which makes the following label revisions:
 - a. Change the product registration number to "EPA Reg. No. 66330-369".
 - b. Within the First Aid box delete "or clothing" in the "If on skin" row and move that row before "If in eyes"

- c. Revise the "Hazards to Humans and Domestic Animals" section to read as follows:
"Corrosive. Causes skin burns and irreversible eye damage. May be fatal if absorbed through skin. Harmful if swallowed. Do not get in eyes, on skin, or on clothing. Wear protective eyewear (goggles, face shield, or safety glasses). Wear coveralls worn over long-sleeved shirt and long pants, socks, chemical-resistant footwear and gloves. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco. Remove and wash contaminated clothing before reuse.
- d. Under "Environmental Hazards" within the last sentence insert parentheses around EPA and insert "Environmental Protection Agency" before it.
- e. Under "Direction for Use" insert "Only" before the sentence "" For formulating into end-use..."
- f. Within the "Storage and Disposal" box insert "Pesticide" before the subheading "Storage".
