On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

This product is conditionally registered in accordance with FIFRA sec. 3(c)(7)(A) provided that you:

1. Submit and/or cite all data required for registration/ reregistration of your product under FIFRA sec. 3(c)(5) when the Agency requires all registrants of similar products to submit such data; and submit acceptable responses required for reregistration of your product under FIFRA section 4.
2. Make the following label changes before you release the product for shipment:
 - a. Revise the "EPA Registration Number to read, "EPA Reg. No. 66397-4".
 - b. Change the heading "Environmental Hazard" to read: "Environmental Hazards".
 - c. Change the heading "Physical or Chemical Hazard" to read: "Physical or Chemical Hazards".
3. You must, upon completion, submit the results of the twelve-month study of storage stability and corrosion characteristics certified to GPL standards.
4. Submit two copies of the revised final printed label for the record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

PRECAUTIONARY STATEMENTS

DANGER - HAZARD TO HUMANS AND DOMESTIC ANIMALS

Corrosive: Causes irreversible eye damage and skin burns. May be fatal if inhaled. Harmful if swallowed or absorbed through skin. Do not get in eyes, on skin or clothing. Do not breathe dust, vapor or spray mist. Irritating to nose and throat. Wear goggles, face shield or safety glasses. Wash thoroughly with soap and water after handling. FIRST AID:

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or doctor for treatment advice.

IF IN EYES: Hold eye open and rinse slowly with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage.

ENVIRONMENTAL HAZARD

This pesticide is toxic to fish and aquatic organisms. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans, or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge effluent containing this product into sewer systems without previously notifying the sewage treatment plant authority. For guidance, contact your State Water Board or Regional Office of EPA.

PHYSICAL OR CHEMICAL HAZARD

Strong oxidizing agent. Contact with water slowly liberates irritating and hazardous chlorine containing gases. Decomposes at temperatures above 437°F (225°) with liberation of harmful gases. When ignited, will burn with the evolution of chlorine and equally toxic gases.

IN CASE OF FIRE OR SMOKE: Call the fire department. Do not attempt to extinguish the fire without a self contained breathing apparatus (SCBA). Do not let the fire burn. Flood with copious amounts of water. Do not use ABC or other dry chemical extinguishers since there is the potential for a violent reaction.

IN CASE OF CONTAMINATION OR DECOMPOSITION: Do not reseal container. Neutralize material to a non-oxidizing state for safe disposal.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

FOR INDUSTRIAL USE ONLY

This product is intended for repackaging and formulating as a microbiocide/microbiostat disinfectant, sanitizer, bactericide, fungicide, or algacide into end-use products for the following general use sites: aquatic non-food industrial, aquatic non-food residential, indoor food, indoor non-food, and indoor residential.

Re-packers or formulators using this product are responsible for obtaining EPA registration of their products.

This product may be used by manufacturers of non-pesticidal products provided no pesticidal claim is made.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal

STORAGE: Keep material dry and in a dry area. Store in original container where temperatures do not exceed 125°F (52°C) for 24 hours. Retie polyethylene liner after each use and keep container tightly closed.

PESTICIDE DISPOSAL: Pesticide wastes are toxic. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal Law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office for guidance.
