DIRECTIONS FOR USE: It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

Remove BUGCHASER INSECT REPELLANT WRISTBAND STRIP from reusable barrier bag and place around ankle, wrist, clothing or anywhere protection is needed 10 minutes before going outside. Snap the ends together for a secure fit. Replacement with a fresh strip every four hours may be needed to maintain satisfactory repellency. Return to reusable barrier bag when not in use to prolong life of product. The strip can also be hung up or placed anywhere indoors where mosquitoes or houseflies are attracted.
