STATEMENT OF PRACTICAL TREATMENT

If swallowed: DO NOT induce vomiting. Product contains petroleum distillates. Give patient one or two glasses of water and call a physician immediately. Never give anything by mouth to an unconscious person.

If inhaled: Remove affected person to fresh air. Apply artificial respiration if indicated.

If in eyes: Flush eyes with plenty of water. Get medical attention if irritation persists.

If on skin: Wash thoroughly with soap and water.

NOTE TO PHYSICIAN: Atropine sulfate is anti-dotal.

STORAGE AND DISPOSAL: Store in a cool place. Keep away from direct sunlight, radiators, stoves and other heat. Do not store below 32°F. Material will freeze and may result in a burst can. Product may be reconstituted by agitation and warming to 70°F. Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited.
Pesticide Disposal: Pesticide, spray mixture or rinse water that cannot be used according to label instructions must be disposed of according to applicable Federal, state or local procedures.
Container Disposal: Triple rinse (or equivalent). Then offer for recycling or reconditioning or dispose of in sanitary landfill or by other approved state and local procedures.

DIRECTIONS FOR USE:

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

ROACH and ANT SPRAY is a highly effective formulation which provides rapid kill of the crawling insects and pests listed below, including those resistant to certain chlorinated hydrocarbon and phosphorus insecticides.

Fleas	Millipedes
Roaches	Scorpions

In addition to rapid kill **ROACH and ANT SPRAY** stays on treated surfaces and kills insects for up to two weeks after the spray deposit has dried.

HOW TO USE: **ROACH and ANT SPRAY** is ready to use undiluted as it comes from the can, and must be applied using a compressed air sprayer. This product may not be used with trigger-type or finger-operated sprayers. Apply as a coarse spray to infested surfaces until wet, moving the spray stream rapidly enough to prevent excessive wetting of surfaces and waste of material. Direct spray away from people and plants.

USE RESTRICTIONS: Do not apply to rugs, carpets, draperies, wallpaper, or similar materials that may be stained. Avoid excessive wetting of plastic, rubber and asphalt surfaces such as tires and floor coverings.

OUTDOOR USE:

ANTS, CLOVER MITES, CRICKETS, EARWIGS, FLEAS, MILLIPEDES, SCORPIONS, AND BROWN DOG TICKS: Spray infested areas thoroughly including outside surfaces of screens, doors, window frames, foundations, patios, or other places where insects may enter. Repeat as necessary. Do not spray vegetation.

INDOOR USE:

ANTS, COCKROACHES, CRICKETS, SILVERFISH, SPIDERS, SCORPIONS, WATERBUGS: Spray into cracks, crevices and around baseboards. Apply behind and beneath cabinets, refrigerators, sinks, stoves, and in and around waste containers. Restill as needed. Do not spray foodstuffs or house plants. For ants, spray trails and places where ants enter premises. Do not allow children to contact treated areas until surfaces are thoroughly dry.

BROWN DOG TICKS: Spray around baseboards, window and door frames, wall cracks, and local areas of floors. Repeat as needed. Do not spray pets or sleeping quarters of pigs.

USE IN FOOD HANDLING ESTABLISHMENTS: Places other than private residences in which exposed food is held, processed, prepared or served.

FOOD AREAS - APPLICATION LIMITED TO CRACK AND CREVICE TREATMENT ONLY. Includes areas for receiving, storage, packing (canning, bottling, wrapping, boxing), preparing, edible waste storage and enclosed processing systems (mills, grinders, edible oils, syrups). Serving areas (when food is exposed and facility is in operation) also would be considered a food area.

Apply in small amounts directly into cracks and crevices using equipment capable of delivering a pin stream in points between different elements of construction, between equipment and floors, openings leading to rods and hollow spaces in walls, equipment legs and bases, conduits, meter housing, junction or switch boxes, where Roaches, Ants and Waterbugs hide.

Prior to application de-energize electrical equipment. After application, allow time for oil to evaporate before starting motors or placing switches in "on" position.

APPLICATIONS OF THIS PRODUCT IN THE FOOD AREAS OF FOOD HANDLING ESTABLISHMENTS OTHER THAN AS A CRACK AND CREVICE TREATMENT ARE NOT PERMITTED.

SERVING AREAS: Facilities where prepared foods are served, such as dining rooms, but excluding areas where foods may be prepared or held.

Apply as a spot treatment to selective surfaces such as baseboards, under elements of construction into cracks and crevices. Avoid treating surfaces likely to be contacted by food. (Do not apply when facility is in operation or foods are exposed.)

NON-FOOD AREAS: Includes garbage rooms, lavatories, floor drains (to sewers), entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets and storage (after canning or bottling).

Apply to baseboards, areas around water pipes, surfaces behind and beneath sinks, lockers, tables, patios and similar areas where insects hide or through which they may enter.

DO NOT APPLY AS A SPACE SPRAY.

ENVIRONMENTAL HAZARDS

This product is toxic to birds and other wildlife. Keep out of any body of water. Do not contaminate water by cleaning of equipment, or disposal of equipment washwaters. Apply this product only as specified on label.
