The label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Three copies of the finished labeling must be submitted.

Label Comments:

A. Under the heading "Warning" delete all wording down to "Net Contents" and replace with the following:

Statement of Practical Treatment

If Swallowed: Call a physician immediately.

If Inhaled: Remove victim to fresh air. Apply respiration if indicated and call a physician.

If in Eyes: Flush with plenty of water. Get medical attention.

If on Skin: Wash with plenty of soap and water after handling. Get medical attention if irritation persists.

Note to Physicians: This product may cause cholinesterase inhibition. Atropine is antidotal. Pralidoxime chloride (2-PAM; PROTOPAM chloride) may be effective as an adjunct to atropine.

Disposal: Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by state and local authorities.

General: Consult Federal, State or local disposal authorities for approved alternative procedures.
