Your Submissions Dated February 25 and November 13, 1993

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable provided that you make the labeling changes indicated below prior to release for shipment of product bearing the amended labeling.

On the front label panel revise the ingredient statement to read as follows:

ACTIVE INGREDIENT:

- 2. On Back Panels 1-4, place the heading **Directions For Use** above the misuse violation statement.
- 3. On Back Panel 2, make the following changes:
 - a. Add "Residential" in parenthesis after Domestic,
 i.e., Domestic (Residential) Use.
 - b. To facilitate quick identification by the customer, the list of pests should appear on the front label panel or after the misuse violation statement in the Directions for Use section.
 - c. Delete "Non-food/feed areas" in the sentence beginning "For control of crawling insects...."

- 4. On Back Panel 3, make the following changes:
 - a. Delete the word **Garden** from the alternate brand name since the labeling does not contain directions for garden use.
- 3. On Back Panels 2-4 make the following changes:
 - a. Delete the paragraphs intitled "Use crack, crevice and spot treatment where food and feed...." and "Use spot treatments in areas...." since these directions are intended for commercial use and not residential use and replace with:

In the home, cover all food handling surfaces and cover or remove all food and cooking utensils and wash thoroughly after treatment.

4. For Back Panel 4, add Residential to the term "Indoor Use", i.e., Indoor Residential Use, since that is the intended market for this product.

A review of the primary irritation study submitted February 25, 1993 indicated that this product can be placed in Toxicity Category IV with respect to eye effects. Thus you may delete the statement of practical treatment and the phrase "Avoid contact with eyes." under the precautionary statements. A copy of the eye irritation review is enclosed for your records.

Submit two copies of your final printed labeling before you release the product for shipment. A stamped copy of the labeling is enclosed for your records.

Back Panel #2: lists directions for use for INSECOLO ALL PURPOSE in domestic living spaces and gardens. This panel will be used only on containers sold for use by these customers. The other Front Panel titles with subtitles will be deleted.

Back Panel #3: lists directions for use for INSECOLO ANT CONTROL in domestic living spaces and gardens. This panel will be used only on containers sold for use by these customers. The other Front Panel titles with subtitles will be deleted.

Back Panel #4: lists directions for use for INSECOLO COCKROACH in domestic living spaces. This panel will be used only on containers sold for use by these customers. The other Front Panel titles with subtitles will be deleted.

Back Panel #5: lists directions for use for INSECOLO FLEA (""
TICK in domestic living spaces. This panel will be used only;

INSECOLO - Flea & Tick is most effective when applied directly to the insect or in the areas the insect frequents.

Directions for Use

In order to maintain control of fleas and ticks on your pet, it is necessary to first bathe them using a flea soap or a good dish detergent. At the same time, wash pet's bedding with hot, soapy water to eliminate any fleas, ticks, farvae or eggs that may be present. *Insecolo* should be dusted to pet's bedding when bedding is dry.

If your home is infested with fleas or ticks it is important that you do a thorough vacuuming of your entire living space. We recommend using a new vacuum bag as the suction will be greater. Dispose of the bag in an outside trash bin. You should then dust the following areas: carpets (7oz per 500 sq. ft.), under and behind furniture, under cushions and along baseboards, particularily in the areas where your pet plays or sleeps. A thorough application is required for good control. After you have dusted Insecolo, you should leave it down for a couple of hours then lightly vacuum, leaving some *Insecolo* under your furniture and in the cracks and crevices of the infested areas.

Death of an individual flea or tick that has come in full contact with *Insecolo* will occur between 2 to 48 hours. It is important to realize that if you have anindoor/outdoor pet, then you will most likely have fleas and ticks being brought into your home on a regular basis during flea season. This will require an ongoing process of washing your pet and its bedding, regular dusting of the pet's bedding with *Insecolo* and frequent vacuuming of your home. When used according to directions, death of fleas and ticks in infested areas continues until the product is depleted, dampened or removed. *Insecolo Flea & Tick* can be removed with a vacuum, mop, sponge or by sweeping dampened dust.

When used as directed, control of crawling insects in stored grains and seeds continues throughout the storage period and, after storage, grains or seeds can be used as intended without removal of INSECOLO.

INSECOLO can be used in any dry container where grain and seed are transported or stored, such as silos or elevators, rail cars, ships, truck trailers, and appropriate cans, drums or packages. It provides maximum control when the moisture content of stored grain or seed is 12-15% or less. Long term effectiveness is improved if temperature during storage is high enough to hatch all insect eggs.

If this product, grain or seed are damp before application, do not use. Reduced effectiveness will result if this product or the grain or seed become damp after application. If this occurs, dry grain or seed and reapply INSECOLO.

INSECOLO is approved for use in the following stored grains and seeds:

Directions for Commercial use: INSECOLO may be applied to grain or seed at any stage of preparation or transportation after drying and before storage. Two to seven pounds of INSECOLO should be mixed thoroughly with each ton of dry grain or seed to be stored. A hopper with a variable rate auger or conveyor feeder can be used to apply INSECOLO during transfer of material into transportation containers or to the storage area.

Test weight per bushel of seed or grain treated with INSECOLO will be reduced slightly, but this reduction in bulk density should not cause the treated material to be reduced to sample grade if the USDA procedures in GR Instruction 918-6 Aux, 1, dated May 9, 1963 are followed. Stored material treated with INSECOLO will be coated with dust, which may reduce movement speed.
