DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

INSECOLO is most effective when applied directly to the insect or in areas that the insect frequents. For continuous control, INSECOLO should be dusted lightly to any and all dry areas where insects crawl or run. Avoid breathing dust. Do not use as a space spray. Do not apply where children or patients can contact dust. In the home, cover all food handling surfaces and cover or remove utensils and wash thoroughly after treatment.

For proper control, insects must come into full contact with INSECOLO. Therefore, it may take several days or applications to control an entire colony or group of insects because of eggs and newly hatched larvae.
