STATEMENT OF PRACTICAL TREATMENT

IF SWALLOWED: Call a physician or Poison Control Center immediately. Drink 1 or 2 glasses of water and induce vomiting by touching the back of throat with finger. Repeat until vomit fluid is clear. Do not induce vomiting or give anything by mouth to an unconscious or convulsing person.

IF INHALED : Remove victim to fresh air. If not breathing, then give artificial respiration.

IF ON SKIN : Wash promptly with plenty of soap and water. Get medical attention.

IF IN EYES: Rinse eyes with plenty of water, get medical attention of irritation persists.

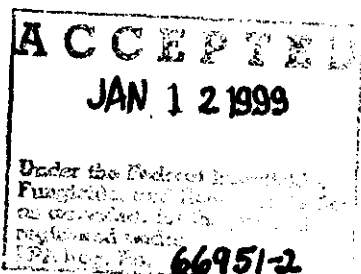
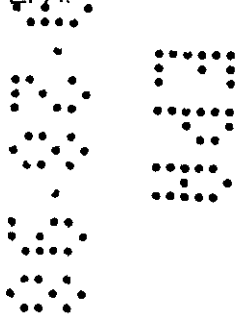

This technical product may be formulated into end-use products solely for the uses listed below:

- (1) **AGRICULTURAL USES:** Treatment of seeds for the following agricultural crops: Barley, broccoli, brussels sprouts, cabbage, cauliflower, celery, collards, corn, lettuce, kale, kohlrabi, mustard greens, oats, radishes, rye, sorghum, spinach, Swiss chard, and wheat.
- (2) Uses for which EPA has accepted the required data and/or citation of data that the formulator has submitted in support of registration; and
- (3) Uses for experimental purposes that are in compliance with EPA requirements.

STORAGE AND DISPOSAL
