To Kill Fleas, Lice and Ticks: Bathe pet with a quality cleaning shampoo. Dilute 4 ounces of dip concentrate with 1 gallon of water. Dip animal into solution, making sure hair is wet to the skin. The area around the ears should be thoroughly sponged. Avoid contact of material with eyes and mouth of animal. Do not rinse off. Repeat as necessary for control.

STORAGE AND DISPOSAL

Storage: Store in a cool, dry place. Keep container closed. Disposal: Do not reuse empty container; wrap and put in trash collection.
