Storage and Disposal

Storage: Store in original container in a cool, dry place inaccessible to children and pets. Protect from freezing. **Disposal:** Do not reuse empty container; wrap and put in trash collection.

To kill crawling insects (*Ants, Boxelder Bugs, Centipedes, Clover Mites, Cockroaches, Crickets, Earwigs, Grain Mites, Silverfish, Sowbugs and Spiders*), turn sprayer nozzle to stream position and spray directly into cracks, crevices and other hiding places along baseboards, hitting as many bugs as possible. Repeat as necessary. Keep about three feet away from walls, fabrics and furniture.

To kill flying insects (*Flies, Gnats, Houseflies, Mediterranean Flour Moths, Mosquitoes and Small Flying Moths*), turn sprayer nozzle to spray position. Direct spray at an upward angle distributing it uniformly throughout the entire area at a rate of 3 to 6 ounces per 1,000 cubic feet. Keep about three feet away from walls, fabrics and furniture. Leave treated areas for a few minutes and ventilate prior to reoccupying.

To kill *Hornets and Wasps* turn sprayer nozzle to stream position. Spray directly on insects whenever possible. Apply a wet spray after dark when all insects have returned to their nests.

To kill garden insects on houseplants and ornamental plants outdoors, turn sprayer nozzle to spray position. Direct spray so that upper and lower leaf surfaces are contacted. To control *Aphids, Bagworms, Flea Beetles, Japanese Beetles, Lace Bugs, Leaf Hoppers, Leaf-tiers, Mimosa Webworm Larvae, Plant Bugs, Thrips and Whiteflies*, use fine mist spray about 18 to 24 inches from infested plants. Use caution on new growth and tender foliage. Repeat treatment as necessary. Avoid spraying plants when temperature exceeds 85°F. Spray when air is still. Avoid heavy wetting.

USE ONLY ON DOGS AND CATS

To kill *Fleas and Ticks* on dogs and cats, turn sprayer nozzle to spray position. Start spraying at the animal's head, avoiding the eyes, nose and mouth as you spray. Make sure the animal's entire body is covered including the legs, underbody and tail. While spraying, fluff the hair so that the spray will penetrate the skin. Make sure spray wets thoroughly. Avoid contact with genitalia. Do not repeat treatment for three days. Do not use on puppies or kittens under 12 weeks. Consult a veterinarian before using this product on debilitated, medicated, aged, pregnant or nursing animals.

To control *Fleas and Brown Dog Ticks* in pet areas on premises, turn sprayer nozzle to spray position. Thoroughly spray infested areas, pet beds, resting quarters, nearby cracks and crevices, along and behind baseboards, moldings, window and doorframes and entire areas of floor and floor covering. Fresh bedding should be placed in animal quarters following treatment. Concurrent treatment of animals is recommended. Repeat treatment as needed.

To protect cattle, horses and hogs from *Horn Flies, House Flies, Mosquitoes and Gnats*, turn sprayer nozzle to spray position and apply a light mist sufficient to wet the surface of the hair. To control *Deer Flies, Horse Flies and Stable Flies* apply at a rate of two ounces per adult animal sufficient to wet the hair thoroughly. Repeat treatment daily or at intervals necessary to give continued protection. To control *Blood Sucking Lice* apply to the infested areas of the animal, using a stiff brush to get the spray to the base of the hair. Repeat every two to three weeks if required.

To control *Poultry Lice*, turn sprayer nozzle to spray position and spray roosts, walls and nests or cages thoroughly. This should be followed by spraying over the birds with a fine mist. For control of *Bedbugs and Mites* in poultry houses, spray crevices or roost poles, cracks in walls and cracks in nests where the bedbugs and mites hide.

CAUTION: Humans: Harmful if inhaled or absorbed through the skin. Avoid breathing spray mist or vapor. Wash thoroughly with soap and water after handling. Remove pets, birds and cover fish aquaria before space spraying or surface applications. **Animals:** Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur, bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

If on Skin: Wash with plenty of soap and water. Get medical attention if irritation persists. **If Inhaled:** Remove victim to fresh air. If not breathing, give artificial respiration, preferably mouth-to-mouth. Get medical attention.
