

Dear Ms. Anastasiou:

The amendment referred to above, submitted in connection with registration under FIFRA section 3(c)(5), is acceptable provided that you:

1. Submit and/or cite all data required for registration/reregistration of your product under FIFRA section 3(c)(5) when the Agency requires all registrants of similar products to submit such data.

2. Submit five (5) copies of your final printed labeling before you release the product for shipment. Final printed labeling means the label or labeling of the product when distributed or sold. Clearly legible reproductions or photo reductions will be accepted for unusual labels, such as those silk-screened directly onto glass or metal containers or large bags or drum labels.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions. 

ENVIRONMENTAL HAZARDS

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. <u>General [Directions]</u>: Apply in a covered area such as a barn or stall. For best results apply to a clean horse. Prior to application, brush coat to remove excess dirt and dust. <u>Dilution Directions</u>: To be used in a clean spray container of your choice. Dilute with 5 parts water to 1 part horse spray. When pest pressure is high, dilute 4 parts water to 1 part horse spray.

<u>Application [Directions][Instructions]:</u> SHAKE CONTAINER BEFORE EACH APPLICATION. Hold spray container 10 to 12 inches from coat for best application. Do not spray solution directly onto horse's facial area. Instead, spray solution onto clean cloth and use cloth to apply Aloe Herbal Horse Spray to horse's facial area. Reapply every 3 hours or as needed.

Do not use on animals intended for human consumption.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE: Store only in a cool, dry area inaccessible to children and pets. Keep container tightly closed when not in use.

PESTICIDE DISPOSAL: Wastes resulting from use of this product may be used on site or at an approved waste disposal facility.

Nonrefillable container. Do not reuse or refill this container. Clean container promptly arter is emptying. Triple Rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins te drip. Repeat this procedure two more times. Then offer for recycling if available or place in trash or in a for sanitary landfill.
