Dear Mr. Sargent:

I. Label Amendment:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable, provided you make the following changes.

- On the front panel of Sub-Label A (Non-Residential/Non-Household) and Sub-Label B (Residential/Household), revise the statement directly below the product name to read: "Restricts wavelengths of sunlight to control algae and aquatic vegetation and also colors the water blue." EPA believes the statement "... and also colors water <u>a beautiful aqua</u> blue" may potentially encourage inappropriate use of this pesticide product.
- 2. On Sub-Label A and Sub-Label B, under "User Safety Requirement", change the <u>first</u> occurrence of "PPE" to "Personal Protective Equipment (PPE)."
- 3. On Sub-Label A and Sub-Label B, under "User Safety Recommendations", insert the word "using" in front of "tobacco", so that the first statement reads "Users should wash hands before eating, drinking, chewing gum, using tobacco, or using the toilet."

- 4. On Sub-Label A (Non-Residential/Non-Household), insert the following statements at the beginning of the Container Disposal section: "Non-refillable container. Do not reuse or refill this container." The remaining statements, beginning with "Triple rinse (or equivalent)" are acceptable as written.
- 5. On Sub-Label B (Residential/Household), insert the statements "Non-refillable container. Do not reuse or refill this container." at the beginning of the Pesticide Disposal section and delete the statement "Do not reuse this container" from the instructions for empty containers (i.e., "If empty:").

A stamped copy of your label is enclosed for your records. This label supersedes all previously accepted labels. You must submit one (1) copy of the final printed label before you release the product for shipment. Products shipped after eighteen (18) months from the date of this letter or the next printing of the label, whichever occurs first, must bear the new revised label. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA §6(e). Your release for shipment of the product constitutes acceptance of these conditions.


II. Revised CSF:
