On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act.

Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under the Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

Based on your response to the Reregistration Eligibility Document for Methylisothiazolene RED, EPA has reregistered the above name product subject to the comments recorded in the succeeding paragraph. Reregistration under this section does not eliminate the need for continual reassessment of pesticides. EPA may require submission of data at any time to maintain the registration of your product.

- b. The word "PELIGRO" must be added to the label, following the signal word "DANGER".

c. As per the Acute Toxicity Review dated May 8, 2000, the First Aid statements must be revised as specified below:

IF IN EYES:

Hold eye open and rinse slowly and gently with **water** for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing. **Call a poison control center or doctor for treatment advice.**

IF SWALLOWED:

Call a poison control center or doctor **immediately for treatment advice.** Have person sip a glass of water if able to swallow. Do not induce vomiting **unless told to** by a poison control center or doctor.

IF ON SKIN:

Take off contaminated clothing. Rinse skin **immediately** with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment.

IF INHALED:

Move person to fresh air. If person is not **breathing**, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth, if possible. **Call a poison control center or doctor for further treatment.**

d. As per the Acute Toxicity Review dated May 8, 2000, the Precautionary Statements" that appear under the subheading "Hazards to Humans and Domestic Animals" must be revised to read as follows:

DANGER

Corrosive. Causes irreversible eye damage. Harmful if absorbed through skin.

Do not get in eyes, on skin, or on clothing. Avoid contact with skin. Prolonged or frequently repeated skin contact may cause allergic reaction in some individuals.

Remove contaminated clothing and wash before reuse".

e. As per the Acute Toxicity Review dated May 8, 2000 and the RED, the PPE must be modified to read as follows:

Personal Protective Equipment (PPE)

Mixers, loaders, and others exposed to methylisothiazolinone must wear:

- Long-sleeved shirt and long pants
- Socks and shoes
- Goggles or face shield
- Chemical-resistant gloves (such as rubber or made out of any waterproof material)

f. As per the RED, the following information must be added to the User Safety Requirements:

"Discard clothing or other absorbent materials that have been drenched or heavily contaminated with this product's concentrate".

g. Include a "Physical and Chemical Hazard" heading and place the text "This product is corrosive to mild steel" directly below it.

h. In the Storage and Disposal section, change the subheading "Storage" to "Pesticide Storage".

i. Move the statement "Do not apply this product in a way that will contact workers or other persons" and place directly below the storage and disposal section.



Acticide DQ is added at a level of 0.4 to 1.5 lb. (180 - 680 grams) to each 1000lb. (453.6 kilograms) of product to be protected to provide 6 to 22.5 ppm of active isothiazolinones.

For control of bacteria and fungi in liquid detergents, in liquid laundry products and also in dishwashing detergents, waxes, polishes, and other similar cleaners, use 0.4 to 1.0 lb. of Acticide DQ per each 1000lb. (453.6 kilograms) of treated product to provide a level of 6 to 15 ppm of active ingredient (isothiazolinones).

Acticide DQ may also be used for control of bacteria and fungi in package utility products such as pre-moistened sponges and mops. Use 0.4 to 1.5 lb. in each 1000 lb. of water to pre-moisten sponges and mops.
