The amendment, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, to make a minor adjustment to the nominal concentrations of the active ingredients, is acceptable.

The Basic Confidential Statement of Formula (CSF) dated December 15, 2003 is in agreement with the label and is acceptable. However, the registration number of the supplier of the active ingredient in Column 12 was not included on the CSF.

Please note that the Agency has allowed the change in the nominal concentration of the above product registration as a one-time only amendment. Please refer to the enclosed Product Chemistry Review for further details.

For control of bacteria and fungi in liquid detergents, in liquid laundry products and also in dishwashing detergents, waxes, polishes, and other similar cleaners, use 0.4 to 1.0 lb. of Acticide DQ per each 1000lb. (453.6 kilograms) of treated product to provide a level of 6 to 15 ppm of active ingredient (isothiazolinones).

Acticide DQ may also be used for control of bacteria and fungi in package utility products such as pre-moistened sponges and mops. Use 0.4 to 1.5 lb. in each 1000 lb. of water to pre-moistened sponges and mops.
