c. As per the Acute Toxicity Review dated May 8, 2000, the First Aid statements must be revised as specified below:

IF IN EYES:

Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing. Call a poison control center or doctor for treatment advice.

IF SWALLOWED:

Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to by a poison control center or doctor.

IF ON SKIN:

Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment.

IF INHALED:

Corrosive. Causes irreversible eye damage. Harmful if absorbed through skin. Do not get in eyes, on skin, or on clothing. Avoid contact with skin. Prolonged or frequently repeated skin contact may cause allergic reaction in some individuals. Remove contaminated clothing and wash before reuse".

f. As per the Acute Toxicity Review dated May 8, 2000 and the RED, the PPE must be modified to read as follows:

Personal Protective Equipment (PPE)

Mixers, loaders, and others exposed to methylisothiazolinone must wear:

- Long-sleeved shirt and long pants
- Socks and shoes
- Goggles or face shield
- Chemical-resistant gloves (such as rubber or made out of any waterproof material)

 - "Discard clothing or other absorbent materials that have been drenched or heavily contaminated with this product's concentrate".
- h. Include a "Physical and Chemical Hazard" heading and place the text "This product is corrosive to mild steel" directly below it.
- i. In the Storage and Disposal section, change the subheading "Prohibitions" to "Pesticide Storage" and include the word "water" to the statement "Do not contaminate food or feed by storage, disposal, or cleaning of equipment".
- j. Include the statement "Do not apply this product in a way that will contact workers or other persons" to fall directly below the storage and disposal section.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. Do not apply this product in a way that will contact workers or other persons

INDUSTRIAL RECIRCULATING WATER COOLING TOWER: Acticide RS-WT microbiocide is recommended for the control of becteria, signe and fundi. It should be added to the tower basin or some other point to ensure uniform mixing.

Add 0.3 to 1.86 lb of Acticide RS-WT per 1000 gallons of water (35 to 220 ppm Acticide RS-WT) weekly or as needed for maintenance. For noticeably fouled systems use an initial dose of 1.26 to 7.5 lb Acticide RS-WT per 1000 gallons of water. Repeat if necessary to achieve control.

AIR WASHER SYSTEMS: For use only in industrial air washing systems that maintain effective mist eliminating components.

Add 0.3 to 7.5 to Acticide RS-WT to 1000 gallons of water (35 to 886 ppm Acticide RS-WT) in the air washer sump, or chill water sump to ensure uniform mixing, for the control of bacteria, fungi and algae. A repeat treatment may be needed depending on the severity of contamination.

OIL FIELD INJECTION WATERS; Add 23.5 to 58 to (2.8 to 6.9 gallons) Acticide RS-WT per 1000 berreis of water (67 to 156 ppm Acticide RS-WT) weekly or as needed to maintain control of slime-forming and sulfate reducing bacteria in oil and gas field water systems including enhanced recovery injection fluids and drilling fluids, An initial dose of 58 to 117 lb Acticide RS-WT per 1000 barrels of water (165 to 330 ppm Acticide RS-WI) may be used until control is achieved. This product may be used for terrestrial and off-shore oil drilling muds and packer fluids.

PAPER MILLS: Add 0.45 to 1.5 lb of Acticide RS-WT per ton (dry basis) of pulp or paper produced as slug dose for the control of bacterial and fungal slime in the production of paper. Acticide RS-WT should be added to a point such as the Beater or Hydropulper to ensure uniform mixing.

INDUSTRIAL RECIRCULATING CLOSED LOOP WATER COOLING SYSTEMS: Add 0.3 to 1.86 lb of Acticide RS-WT per 1000 gallions of water in the system weekly to maintain control of bacteria, fungi and algae in the reservoir, recirculating line or some other point to ensure uniform mixing. For noticeably fouled systems an initial treatment with 1.25 to 7.5 lb Acticide RS-WT per 1000 gallons of water may be needed depending on the severity of the fouling.

BREWERY PASTEURIZERS AND CAN WARMER SYSTEMS: Add 0.3 to 1.86 lb of Acticide RS-WT per 1000 gallons of water in the system weekly or as needed to maintain control of bacteria, algae and fungi. For noticeably fouled systems an initial treatment with 1.25 to 7.5 lb of Acticide RS-WT per 1000 gailons of water ACCEPTED may be needed depending on the severity of the fouling.
