This label change notification is submitted by Thor Specialties, Inc., U.S. agent for Thor GmbH. notification of label change is as required by the State of California and per PR Notice 98-10 / 95-2.

The State of California requested that we submit this notification with regards to formatting and the addition or removal of the qualifier "*not approved for use in the state of California. The acceptance of this label at the DPR is pending EPA's acceptance of the modified formatting.

Modifications are as follows:

- The following modifications have been made to the label:
 - A) The symbol preceding the first aid instructions has been changed so as not to confuse the user. The asterisk (*) is intended to be the qualifier "*Not approved for use in the state of California"; whereas, the symbol > is intended to precede and bring attention to the first aid instructions.
 - B) The qualifier (*) has been removed from the uses IN-CONTAINER PRESERVATIVE and HOUSEHOLD CONSUMER, INDUSTRIAL, JANITORIAL PRODUCTS
- II) The following modifications have been made to the Information Sheet:
 - C) A qualifier (*) has been added to the front of the uses not currently approved for use in the state of California and the explanation of the asterisk (*) has been included at the end of the use statement to indicate that this particular use is not approved in the state of California.
 - D) The qualifier (*) has been removed from the front of the uses currently under review in the state of California and the explanation of the asterisk (*) has been removed from the end of these uses.
