Cover waxed wood floors and waxed furniture in the immediate area surrounding the fogger (Newspapers may be used). Remove or cover exposed foods, dishes, utensils or food handling equipment. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. Shut off electrical appliances. Do not place activated fogger in a cabinet or under a counter or table. Do not use fogger in an area less than 100 cubic feet.

SHAKE WELL JUST BEPORE USING. Place a section of newspaper on floor in center of room to be treated. NOTE: Do NOT place fogger on water-stainable surface. Do not place can within 6 feet of pilot lights. Tilt can opening away from face and depress tab firmly with thumb until it clicks in locked position. Aiming apray away from face, set fogger on newspaper, leave room and close door. After activation, leave room or house at once. Keep area closed for 2 hours (30 minutes for flying insects) before airing out. Open all doors and windows and allow to air for 30 minutes. Repeat spraying in two weeks or when necessary.
