**DIRECTIONS FOR USE:**

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

This product is labeled to be used in and around the home, yard, animal housing, etc. It can be applied as a dry dust or mixed with water at the rate of 2 ounces per quart and sprayed as a liquid. NOTE: 1 ounce of this product is 8 level teaspoons. The dust does not dissolve, and to help keep it in suspension, add one tablespoon of mild detergent per gallon of water, and agitate the sprayer now and then. With either method, the idea is to coat all areas where bugs may be.

**DRY USE INSTRUCTIONS: HOUSEHOLD INSECTICIDE** can be applied by the use of any equipment to handle dust or powder, whether it be hand or power operated.

**ROACHES & SILVERFISH:** In most cases general application is not needed, but localized attention to cracks & crevices, under stoves & refrigerators, and in likely hiding places. Be sure to treat around sinks and drain pipes, and if there is an opening into the sewer line, blow a considerable amount of product in the line. Being closed, air pressure forces the dust further down the line, coating the upper half of the pipe, leaving no safe place for roaches. This protection exists as far as the line is coated.

**ANTS, CRICKETS, SCORPIONS & BOX ELDER BUGS:** Dust lightly areas around windows, doors and other places where pests may enter. Ant mounds or beds should be treated.

**WET APPLICATION:** Use one cup of dust and one tablespoon of mild detergent in a gallon of water, saturate the mound or bed. Repeat if necessary.

**FLEAS:** Apply liberally to all parts of animal close to skin.  
**RUGS:** Make a thin coating on rug. Rake (not sweep) nap back and forth, causing dust to enter rug. Leave overnight. When cleaning do not make special effort to remove dust in rug. It will kill live fleas, repel others, and will deodorize carpet.

**OUTSIDE AREA:** Apply 8 to 16 oz. of dust per 1000 sq. ft. of yard. Two or three applications per year should do the job. This can be done as dry dust or as wettable powder, using suitable equipment.

**FLIES:** Lightly coat window sills so flies lighting will contact the dust. If the outside walls of the house, shrubbery, outbuildings, such as barns, stables, kennels or corrals are dusted, flies are greatly reduced. Repeat if needed.
