**PLEASE NOTE:** This product is not being reregistered under sections 3(c)5 and 4(g) of FIFRA at this time.

Please note that the record for this product currently contains the accepted CSFs listed below. Any previously dated CSFs are superseded.

**ENVIRONMENTAL HAZARDS**

**PREMISE APPLICATION:** For animals confined to a specific area infested with fleas and ticks, dust the entire area with **PERMA-GUARD PET INSECTICIDE**. Do not allow adults, children or pets to enter until dusts have settled. Do not enter or allow others entry into treated areas during the restricted entry interval (REI) of 12 hours. Remove or cover exposed food and drinking water before application. Remove or cover dishes, utensils, food preparation surfaces or wash them before use.

**DRY APPLICATION:** Cover the affected area at the rate of 8 oz. to 16 oz. per 1,000 sq. ft.

If using a small lawn fertilizer spreader, mix equal parts of dry sand with **PERMA-GUARD PET INSECTICIDE** for even flow. Applications with power duster equipment are prohibited. Dust thoroughly the first time and then re-apply every 4 months if necessary.

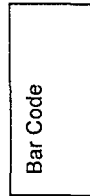
