2. Change the heading "INSECT REPELLENT" to "INSECTS".
  3. Change the heading "ANIMAL REPELLENT" to "RABBITS AND TREE SQUIRRELS".
- B. Within 30 days, submit a revised Confidential Statement of Formula (CSF) to agree with your new label.
- C. Maintain efficacy data for your additional new uses. These must be of guideline quality and may be required to be submitted to enforcement or registration in the future.


If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

## Hot Pepper Wax Ready to Use

### PRECAUTIONARY STATEMENTS

#### Hazards to Humans and Domestic Animals

Caution. Causes eye irritation. Avoid contact with eyes or clothing. Wash thoroughly with soap and water after handling.

#### FIRST AID

**DIRECTIONS FOR USE:** It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**INSECT REPELLENT:** To effectively repel aphids, spider mites, thrips, leaf miners, whiteflies, lace bugs, leafhoppers and scale, spray Hot Pepper Wax Ready to Use on foliage, stems, buds, fruits, and blooms. Hot Pepper Wax Ready to Use can be used on fruits, vegetables, citrus, root crops, legumes, indoor/outdoor ornamentals, and grasses.

**ANIMAL REPELLENT:** To effectively repel rabbits and tree squirrels, spray Hot Pepper Wax Ready to Use on foliage, stems, buds, fruits and blooms. Hot Pepper Wax Ready to Use can be used on fruits, vegetables, citrus, root crops, legumes, indoor/outdoor ornamentals, and grasses. Hot Pepper Wax Ready to Use also can be used to repel animals from chewing wood structures and fences.

**APPLICATION AND TIMING:** *SHAKE WELL*; Apply until foliage or surface is wet. Repeat application in 3-7 days for 2-3 weeks, until control is established. **ONCE CONTROL IS ESTABLISHED**, use every 2-4 weeks, as necessary to maintain control.

#### STORAGE AND DISPOSAL

**STORAGE:** Store only in original container, in a dry place inaccessible to children and pets.  
**DISPOSAL:** Do not reuse empty containers. Rinse thoroughly. Securely wrap in newspaper and discard in trash.

#### WARRANTY

Buyer's guarantee limited to label claims.
