Dear Ms. Griffin:

The Biopesticides and Pollution Prevention Division (BPPD) is in receipt of the above applications for Notification under Pesticide Registration Notice (PRN) 98-10. A preliminary screen of the applications have been conducted for applicability under PRN 98-10 and the Agency has determined that your action to delete the 1-800-CLEANUP number from the storage and disposal section of the residential portion of each label is acceptable (see PRN 2001-6).

However, your action to add to each label the phrase "protects foliage from moisture loss" does not clearly fall within the scope of PRN 98-10 (pg. 11) and is therefore **not acceptable**.

While the phrase "protects foliage from moisture loss" may be a non-pesticidal claim, the Agency will require additional administrative (label) and possible confidential statement of formula, data and/or review of your files to make a determination regarding the accuracy and appropriateness of the claim for these specific pesticide products (LRM pg12, sec A-2).

Be advised that Pesticide Registration Notices are provided as guidance. They are not considered to be regulation by the Agency. BPPD therefore, reserves the right to make the above determination and concludes that the action to add the phrase "protects foliage from moisture loss" to the above product labels must be submitted to the Agency as an amendment. No further processing of this action will occur until a resubmission is made by you.

On behalf of Hot Pepper Wax, Inc., I am submitting a notification per PR Notice 98-10 for the product Hot Pepper Wax Ready to Use, EPA Reg. No. 67238-2 for two items:

- 1) To add optional non-FIFRA language "protects foliage from moisture loss" (page 1 of 3)
- 2) To delete the 1-800 CLEANUP number from the storage and disposal section of the label (see page 3 of 3).

Regarding the 1-800 CLEANUP number, I have spoken with EPA staff person, Nancy Fitz (703-305-7385), who has been involved in the conference calls on this issue. She indicated that EPA is working on a notice that would allow registrants to remove the number from their labels. As Hot Pepper Wax and its distributor are planning to print new labels in the near future, we need EPA approval to delete this number now.

WOODEN STRUCTURES AND FENCES: Hot Pepper Wax Ready to Use repels rabbits and squirrels from chewing on wooden structures and fences. Apply until surface is wet. Repeat application as soon as possible after any nibbling is observed. Once control is established, reapply every 3 to 4 weeks to previously sprayed surfaces.

STORAGE AND DISPOSAL
