

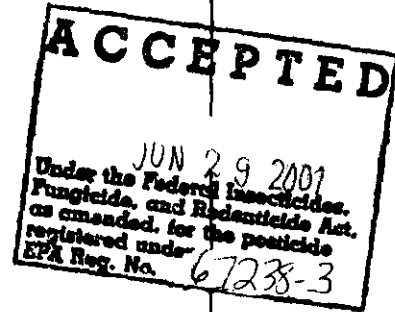

KEEPOUT™ may be used to protect fruit and vegetable plants, flowers, shrubs, trees, and ornamentals against deer and small animal foraging. Avoid use on Variegated African Violets, Sweet Basil, Parsley, Dicentra eximia, and fruit trees when in the pink bud stage until after the petals fall.

OR

KEEPOUT™ may be used to protect flowers, shrubs, trees, and ornamentals against deer and small animal foraging. Avoid use on Variegated African Violets, Sweet Basil, Parsley, and Dicentra eximia.

OR

KEEPOUT™ may be used to protect shrubs, trees, and ornamentals against deer and small animal foraging. Best for over-winter protection. Use when little or no new growth is expected; late fall through early spring, depending on climate.

Rate: KEEPOUT™ should be mixed with water at a rate of 1 part KEEPOUT™ to 16 parts water. (8 fl. oz. product to 1 gallon water).

Application: **Shake well before use.** Remove lid and attach container to hose-end applicator. Push main valve to OFF position. Turn dial on top to the 1:16 ratio and select the appropriate nozzle setting. Slide main valve to ON position and spray product evenly on the plants to be treated. Apply KEEPOUT™ as foliar spray to above ground portions of the plant until wet but not dripping. Thorough coverage of all portions of the plant is essential for repellency. Do not drench roots in soil or media. Do not apply KEEPOUT™ through any type of irrigation system.
