PRODUCT DESCRIPTION: Aqua Chem® Balanced For Clean Pools Algaecide Liquid Concentrate is an extra-strength algaecide specially formulated to destroy blue, green, yellow and mustard algae infestations in pool water. Following its initial application, Algaecide Liquid Concentrate will help prevent algae growth when used every 5-7 days as part of your routine maintenance program.

IMPORTANT NOTES:

1. Aqua Chem Algaecide Liquid may stain plastic, vinyl or freshly plastered pool surfaces. Check with pool manufacturer or supplier before using this product.
2. Always apply this and other pool treatment chemicals separately, never combine them.
3. Sunlight, rainfall, temperature, number of swimmers and frequency of pool use, all affect the rate at which unsanitary pool water conditions develop. Always adjust pool cleaning and maintenance functions accordingly.
4. For removal of black algae, use Aqua Chem Black-Out Algaecide.

DIRECTIONS FOR USE: It is a violation of Federal Law to use this product in any manner inconsistent with its labeling.

BEFORE YOU BEGIN

1. Make sure all pool equipment is working properly, including pump, filter, skimmer and heater.
2. Backwash filter, following normal procedure for your pool's filter.
3. Check residual chlorine level with an Aqua Chem Test Kit, following label directions. Desirable range is 1.0-1.5 parts per million (ppm). If necessary, add Aqua Chem Stabilized Granules or Aqua Chem Liquid Chlorinizer according to label directions till water reaches desired level.
4. Check pH (acidity/alkalinity balance) with an Aqua Chem Test Kit, following label directions. Desired pH range is between 7.2-7.6. If necessary, adjust pH by adding Aqua Chem pH Decreaser to lower pH or Aqua Chem pH Add to raise pH. Follow label directions for those products.

4. Recheck pH and maintain it between 7.2-7.6 for at least 6 hours before adding Aqua Chem Algaecide.

NOW USE AQUA CHEM ALGAECIDE LIQUID CONCENTRATE

1. Add Aqua Chem Algaecide Liquid at a rate of 11-17 fl. oz. per 10,000 gallons of water by pouring algaecide into water at deep end of pool. Wear goggles or face shield and rubber gloves. Also avoid contamination of clothing. (See First Aid information elsewhere on label.)
2. Operate recirculating pump while adding Aqua Chem Algaecide Liquid and for 4 hours afterward to ensure complete distribution and maximum effect.
3. If necessary the next day, brush dead algae off pool surfaces so it can be filtered away. Repeat dosage to remove additional algae spots.
4. To reduce future growth of algae and micro-organisms, a regular maintenance application of this algaecide is recommended. Add Algaecide Liquid at a rate of 2-4 fl. oz. every 5-7 days, or more frequently depending on usage conditions, following directions above.
5. Recheck pH, total alkalinity, and residual chlorine levels following treatment and adjust as necessary, following label directions on Aqua Chem Pool products designed for these purposes.

STORAGE AND DISPOSAL: Keep this product in tightly closed original container, when not in use. Store in a locked, cool, dry, well-ventilated area away from heat or open flame. In case of decomposition, isolate container (if possible) and flood area with large amounts of water to dissolve all materials before discarding this container. Do not reuse empty container but place in trash collection. Do not contaminate food or feed by storage or disposal, or cleaning of equipment.
