One (1) pint used as directed in 1,500 to 6,000 cubic feet ripening room produces ethylene concentrations varying from 5 to 500 P.P.M. over a period of 6-24 hours.

Tobacco. Use in a Catalytic Generator immediately after filling curing system. Two (2) quarts used as directed in 1,500 to 2,500 cubic feet curing system produces ethylene concentrations varying from 15 to 300 P.P.M. over a period of 12 - 24 hours. Use additional two (2) quarts of ETHY-GEN[®] II as required.

USE PRECAUTIONS

Anyone using this product in any other type curing system or room size should contact us prior to use. The ripening room or curing system should be reasonably air-tight, all vents and doors closed, cracks or holes in walls and doors should be repaired or covered over.
