Patented Dual Deterrent System™ provides odor and taste barriers to protect flowers, gardens, grass, ornamental bulbs, ornamental plants, shrubs, seedlings and trees from browsing and feeding by deer, rabbits, and tree squirrels. The weather-resistant formula provides effective protection by forming both an odor and taste barrier to repel pests.

[for 16 fl. oz size only]

Treats 20-25 ornamental shrubs four feet tall or approximately 200-250 square feet, depending on surface conditions, density and size of plantings.

[for 32 fl. oz size only]

Treats 45-50 ornamental shrubs four feet tall or approximately 400-500 square feet, depending on surface conditions, density and size of plantings.

[for 128 fl. oz. size only]

Treats 180-200 ornamental shrubs four feet tall or approximately 1600-2000 square feet, depending on surface conditions, density and size of plantings.

DIRECTIONS FOR USE:

Use to repel deer, rabbits and tree squirrels from flowers, gardens, grass, ornamental bulbs, ornamental plants, shrubs, seedlings and trees. Do not apply at temperatures below 40°F, or in wet, windy conditions. This product will stain structural surfaces. Do not apply to siding, roofing, decks, fences, driveways, painted surfaces or other structural material. Do not allow spray to drift onto structural surfaces in the areas of application.

APPLICATION DIRECTIONS:

Shake the container of DEER-OFF RTU II spray vigorously before use. Spray (non-food) leaves, stems, flowers and branches thoroughly from all angles, until run-off or leaves look wet. Treat vulnerable (non-food) plants at the beginning of each damage season. **Reapply every 2 – 3 months, or as new growth emerges, or if the effects of the previous treatment appear to be waning.**

One pint of DEER-OFF RTU II ready-to-use spray treats 20-25 ornamental shrubs 4 feet tall or an area of about 250 sq. ft. Surface conditions, size and texture of planting will affect the area for treatment with a given quantity of spray. Before large-scale treatments, test product on a small area of plant type to avoid possible plant damage.

[for 32 fl. oz size only]

One quart of DEER-OFF RTU II ready-to-use spray treats 45-50 ornamental shrubs 4 feet tall or an area of about 500 sq. ft. Surface conditions, size and texture of planting will affect the area for treatment with a given quantity of spray. Before large-scale treatments, test product on a small area of plant type to avoid possible plant damage.

[for 128 fl. oz size only]

One gallon of DEER-OFF RTU II ready-to-use spray treats 180-200 ornamental shrubs 4 feet tall or an area of about 2000 sq. ft. Surface conditions, size and texture of planting will affect the area for treatment with a given quantity of spray. Before large-scale treatments, test product on a small area of plant type to avoid possible plant damage.

STORAGE AND DISPOSAL
