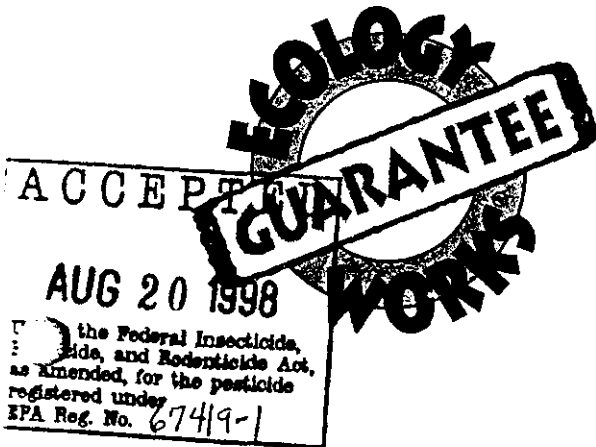

### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

#### 1. FOR USE AS SPRAY:

- First vacuum or deep clean carpet in normal fashion.
- In a clean bucket - mix 1 cup FLEANIX® in 1/2 gallon of water and fill sprayer. Spray evenly to treat 100 sq. ft. A stiff brush or carpet rake will aid penetration on dense carpet pile.
- When applied as spray without vacuum extraction-this bag will treat 1300 sq. ft. of carpet!
- Before treating furniture or drapes, test small area to evaluate staining. When treating couches and chairs, remove cushions and vacuum, then spray all crevices and undersides. Allow to dry before replacing cushions. Spray all pet sleeping areas, including pet bedding. **DO NOT SATURATE.**
- Treat wood-floor cracks, crevices and baseboard with spray or mop, wipe excess solution off exposed surfaces with a dry towel. Treat concrete and dirt floors with a light spray. Avoid contact with treated surfaces until dry.

• Run clean water through sprayer to flush pump after use.

#### 2. USING A HOT-WATER VACUUM CARPET CLEANING MACHINE:

- In a clean bucket - mix 1 cup of FLEANIX® with each gal. of water, then add solution to cleaning machine dispensing tank. When applied with vacuum carpet cleaning machine this bag will treat 650 sq. ft. (six 9x12 carpets)
- For control of fleas in carpet, apply 2 gallons per 100 sq. ft. Clean carpet as directed by hot-water vacuum manufacturer. This process drives FLEANIX® deep into carpet and the vacuum draws out flea dirt, flea eggs, and excess solution. Avoid contact with treated surfaces until dry.

• For control of fleas in upholstery apply FLEANIX® to the underside of cushions and into the crevices of furniture using the upholstery cleaning head. Allow to dry before replacing cushions.

• Run clean water through machine to flush spray-pump after use.

#### 3. FOR USE AS A DRY POWDER ON DRY CARPET SURFACES, FURNITURE, FLOORING AND BASEBOARDS: (Applied as dry powder-this bag treats 1300 sq. ft. of carpet)

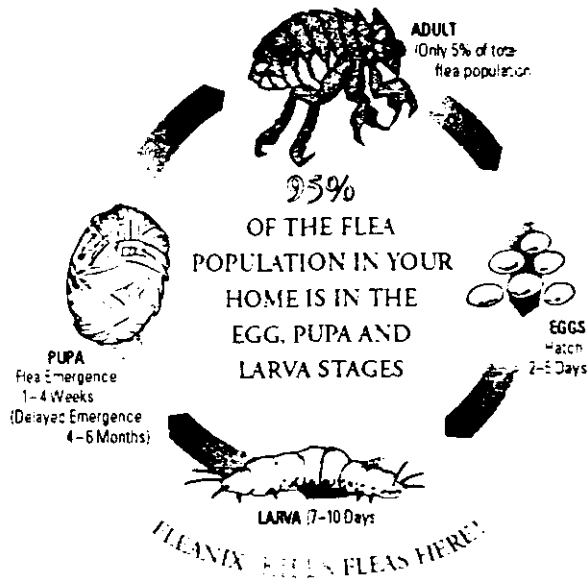
- First vacuum carpet, upholstery, floor and baseboards.
- Sprinkle FLEANIX® powder into carpet at a rate of 1 cup per 100 sq. feet. Brush powder into the carpet with broom or rug rake and do not vacuum for 48 hours. Any powder visible must be brushed into carpet fibers or removed.
- If upholstered furniture is sensitive to moisture apply FLEANIX® as a powder, dusting the wells and under cushions. Remove excess powder by vacuuming.
- Apply powder to cracks and crevices in floors and baseboard-then remove visible excess.

#### STORAGE AND DISPOSAL:

Do not contaminate water, food or feed by storage or disposal.

**STORAGE:** Store in a dry place. Do not store where children or animals may gain access.

**DISPOSAL:** Do not reuse empty container; wrap and place in trash collection.
