

For control of dust mites and fleas in carpet, first vacuum or deep clean carpet in normal fashion. In a clean bucket, mix 1 cup of ECOLOGY WORKS INSECTICIDE in 1/2 gallon of water and fill sprayer. Spray evenly to treat 100 square feet. A stiff brush or carpet rake will aid penetration on dense carpet pile

Before treating furniture, bedding, mattress or drapes, vacuum thoroughly, then test small area to evaluate staining. When treating couches and chairs, remove cushions and vacuum, then spray all crevices and undersides. Allow to dry before replacing cushions. Spray all pet sleeping areas, including pet bedding. DO NOT SATURATE.

For control of dust mites and fleas in carpet, in a clean bucket, mix 1 cup of ECOLOGY WORKS INSECTICIDE with each gallon of carpet cleaning solution and hot tapwater (or plain hot tap water), then add solution to cleaning machine dispensing tank.
