For Ant Mounds/Nests: Sprinkle 1 to 2 teaspoons over the nest. For red imported fire ant mounds, use up to ½ cup (8 tablespoons) over each mound and up to 2 feet around each mound.

For Interior Broadcast Treatments (Attics and Crawl Spaces Only): Apply uniformly around the perimeter and in and around areas where insects may be hiding or living. Apply at a rate of 2 to 4 lbs. per 1000 square feet of surface area, depending on the severity of the problem. Repeat as necessary.
