Yellowjacket Treatment: Stand a safe distance from the underground nest. Hold cannister in an upright position and aim actuator opening toward nest. Apply with a sweeping motion and contact as many yellowjackets around nest opening. Next, approach nest opening and apply directly into opening for 8 seconds to kill yellowjackets in the nest. This will also repel any yellowjackets trying to return to the nest, and cause them to fly away. Repeat as necessary.

**Spider Treatments:** Aim actuator at spiders and web and apply. Contact as many spiders as possible. Repeat as necessary.
