Ants, carpet beetles, centipedes, coelementes, crickets, earwigs, millipedes, pillbugs, scorpions, spiders, thus, clothes moths, flies, gnats, moranitees, moths, yellow jackets, wasps, hornets, and other insect pests.

DIRECTIONS FOR USE:

IT IS A VIOLATION OF FEDERAL LAW TO USE THIS PRODUCT IN A MANNER INCONSISTENT WITH ITS LABELING.

SHAKE WELL BEFORE USING. Hold container upright and aim nozzle away from person. Press button firmly to spray.

For Crawling Insects: Spray into hiding places such as cracks, crevices, openings around sinks, drains and pipes, around appliances, along baseboards and behind cabinets. Spray until wet. Contact as many insects as possible. Repeat as necessary. Ants: Spray ant trails, around doorsills, window frames, or in ant nest. Contact as many ants as possible. Repeat as necessary. Bed Bugs: Spray mattress lightly, particularly around seams and tufts. Take bed apart; spray bed frame and springs including all joints. Repeat as necessary. Fleas and Brown Dog Ticks: Spray infested areas such as pets bed and resting quarters, nearby cracks and crevices, along and behind baseboards, windows and door frames, and localized area of floor and floor covering where these pest may be present. Remove old bedding after treatment. Contact as many insects as possible. Repeat as necessary.

For Flying Insects: Close doors and windows. Direct mist upward in circular sweeping motion to all parts of the room especially around windows and other light sources. Whenever possible, keep doors and windows closed for 15 minutes after treatment. Also direct mist into areas where insects are present. Spray directly on insects for fastest action. Repeat as necessary. Avoid spraying over fish tanks.

Storage & Disposal: Store in a cool, dry area away from heat or open flame. When container is empty, recycle if available. If recycling is not available, wrap in newspaper and place the empty container in a trash collector. Do not puncture or incinerate.
