HAZARDS TO HUMANS AND DOMESTIC ANIMALS
CAUTION**

Hazards to Humans:

Harmful if swallowed or absorbed through the skin. Avoid contact with skin, eyes or clothing. Causes moderate eye irritation. Wash thoroughly with soap and water after handling.

Hazards to Domestic Animals: For external use on adult dogs only. Do not use on dogs less than 6 months of age. Do not use on sick, aged, medicated, pregnant, or nursing pets without consulting a veterinarian. Consult a veterinarian before using on dogs with known organ dysfunction. **DO NOT USE ON CATS** or other animals. Cats which actively groom or engage in close physical contact with recently treated dogs may be at risk of toxic exposure. It is advisable to consult a veterinarian before using this product with other pesticide or drug.

STATEMENT OF PRACTICAL TREATMENT

If Swallowed: Call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger or, if available, by administration of syrup of ipecac. **DO NOT INDUCE VOMITING OR GIVE ANYTHING BY MOUTH TO AN UNCONSCIOUS PERSON.**

If On Skin: Remove contaminated clothing and wash with plenty of soap and water. Get Medical Attention.

If In Eyes: Flush eyes with plenty of water. Call a physician if irritation persists.

Adverse Reactions: Some animals may be sensitive to ingredients in this product. Reactions in dogs may include skin sensitivity. Dogs may show lethargy, increased pruritis, (itchiness), erythema (redness), rash and hair discoloration or hair loss at the application site. Observe the dog following treatment. If sensitivity to the product occurs, discontinue use and bathe the dog with a mild, non-insecticidal shampoo. Seek Veterinary advice.

This product is extremely toxic to fish. Do not add directly to water. Do not contaminate water when disposing of product or packaging.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Read entire label before using. DO NOT USE ON CATS or other animals. Do not get this product in your pet's eyes or mouth. Repeat applications may be made if necessary, but do not apply more often than once every three weeks. Do not use this product in or on electrical equipment due to the possibility of shock hazard.

For Dogs Weighing Less Than 33 pounds: Apply one tube (1.5 ml) of ECTO FLEA & TICK INSECTICIDE WITH IGR solution to the dog's back between the shoulder blades.

For Dogs Weighing More Than 33 pounds: Apply one tube (1.5 ml) of ECTO FLEA & TICK INSECTICIDE WITH IGR solution to the dog's back between the shoulder blades and apply a second tube (1.5 ml) to the dog's back directly in front of the base of the tail.

HOW TO APPLY:

FOR FOLDING CARD OR TABBED CARD UNIT-DOSE PACKAGING: Remove product tab by tearing along perforation. Holding tab with tube end pointed up and away from face and body, cut along dotted line. Invert tab over dog and use narrow end of card to part dog's hair. Squeeze tube firmly to apply all of the solution to the dog's skin. Wrap and put in trash.

FOR FLAT CARD (doubled) UNIT-DOSE PACKAGING: Separate cards along the perforated line. Holding separated card by its wide end with narrow end pointed up and away from the face and body, cut along dotted line. Invert card over dog and use narrow end of card to part dog's hair. Squeeze tube firmly to apply all of the solution to the dog's skin. Wrap card and put in trash.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Storage: Store in cool, dry place. Protect from freezing.

Pesticide Disposal: Securely wrap original container in several layers of newspaper and discard in trash.

Container Disposal: Do not reuse empty container. Wrap container and put in trash.
