Purpose

The purpose of your submission is to amend the label of your product in accordance with our July 17, 2002, letter.

Review of label

The labeling submitted with the above letter, under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) is acceptable, provided that you make the following labeling changes and submit one (1) copy of final printed labeling to us:

- 1. As indicated in our July 17, 2002, letter, change "4oz" to "4-oz" in the first sentence of the use directions "For Norway and Roof Rats:".
- 2. Change "Vitamin K" to "Vitamin K₁, wherever it occurs.
- 3. Retain the "IF SWALLOW" text of your label as <u>mandatory</u>. Because of the large number of oral incidents every year, the person handling the incident needs that information to obtain the advice and reassurance needed.
- 4. Modify house mouse directions as follows:

FOR HOUSE MICE: Open placepack and apply 1/4 to ½ ounce (1-2 level tablespoons) of bait at 8 to 12 foot intervals. Larger placements (up to 2 ounces) ... at least 15 days.

A copy of the stamped label is enclosed for your records.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

READ THIS LABEL: Read this entire label and follow all use directions and use precautions.

IMPORTANT: Do not expose children, pets or other nontarget animals to rodenticides. To help to prevent accidents:

- 1. Store product not in use in a location out of reach of children and pets.
- 2. Apply bait in locations out of the reach of children, pets, domestic animals and nontarget wildlife, or in tamper-resistant bait stations. These stations must be resistant to destruction by dogs and by children under six years of age, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. If bait can be shaken from stations when they are lifted, units must be secured or otherwise immobilized. Even stronger bait stations are needed in areas open to hoofed livestock, raccoons, bears, or other potentially destructive animals, or in areas prone to vandalism.
- 3. Dispose of product container and unused, spoiled and unconsumed bait as specified on this label.

USE RESTRICTIONS: This product may be used to control Norway rats, Roof rats, and House mice in and around homes, industrial and agricultural buildings, and similar man-made structures. Do not place bait in areas where there is a possibility of contaminating food or surfaces that come in direct contact with food. Do not broadcast bait.

SELECTION OF TREATMENT AREAS: Determine areas where rodents will most likely find and consume the bait. Generally, these are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been seen. Protect bait from rain or snow. Remove as much alternative food accessible to rodents as possible.

APPLICATION DIRECTIONS:

FOR NORWAY AND ROOF RATS: Apply one to four 4oz. placepacks per placements. Maintain an uninterrupted supply of fresh bait for at least 10 days.

FOR HOUSE MICE: Apply one placepack and 1/4 to 1/2 ounce (1-2 level tablespoons) of bait at 8 to 12 foot intervals. Larger placements may be needed at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for at least 15 days.

DIRECTIONS FOR USE (CONTINUED)

RATS AND MICE: Replace contaminated or spoiled bait immediately. Collect and properly dispose of all dead rodents and leftover bait. To discourage reinfestation, limit sources of rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.

STORAGE AND DISPOSAL

HOUSEHOLD USE:

PESTICIDE STORAGE: Store only in original container in a cool, dry place inaccessible to children and pets.

CONTAINER DISPOSAL: If **Empty:** Do not reuse this container. Place in trash or offer for recycling if available. If **partly filled:** Call your local solid waste agency or 1-800-CLEANUP for disposal instructions. Never place any unused product down any indoor or outdoor drain.
