<u>LIVESTOCK</u> (except dairy animals) - For control of certain external parasites. <u>Use as spray only.</u> <u>Do not use in dipping vats.</u>

<u>Cattle</u>	Use I quart Methoxychlor Spray I to 12- ½ gallons of water. Apply 2 quarts of spray per mature animal for control of horn flies. For control of short-nosed and long-nosed cattle lice, apply as a drenching spray.
Hogs	For control of line, use I quart Mathemather Spray I to 12, 14

<u>Hogs</u> For control of lice, use I quart Methoxychor Spray I to 12- ½ gallons of water applied as a drenching spray

<u>SELF APPLICATOR FOR FLY CONTROL ON CATTLE</u> (except dairy animals) - For control of horn flies dilute 1 gallon of Methoxychlor Spray I with 4 gallons of diesel fuel or furnace type oil. Do not use any other type of oil. Use 1 gallon of solution to saturate burlap on "back rubber": soak burlap every two to three weeks.

<u>GRAIN STROAGE BINS</u> - To clean up infestations in empty storage bins, use 1 gallon of Methoxychlor Spray in 10 gallons of water. Apply at the rate of 2 gallons of spray per 1000 sq. ft. before products are stored. This aids in control of cadella flat grain beetle, saw-toothed grain beetle, lesser grain borer, red flour beetle, long-headed flour beetle, rice weevil, granary weevil, confused flour beetle, foreign grain beetle and hairy fungus beetle. NOTE - Do not add grain to bin for at least 24 hours or until walls have dried thoroughly.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

Pesticide Storage: Store in original container in an area inaccessible to children.

Pesticide Disposal: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.
