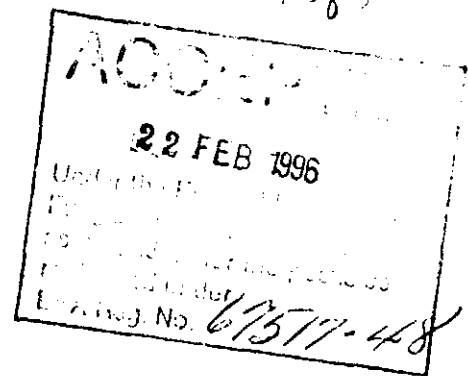

HAZARDS TO HUMANS:

STATEMENT OF PRACTICAL TREATMENT

If In Eyes: Flush eyes with plenty of water. Contact a physician if irritation persists.

If Swallowed: Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious person.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

To prevent harm to you and your pet, read entire label then follow all directions and Precautionary Statements carefully.

Use only on dogs. DO NOT USE ON CATS or other animals. Do not get this product in your pets eyes or mouth. Wash hands and exposed skin thoroughly with soap and water after use.

Wet the dog thoroughly with lukewarm water. Apply a small amount of Canine Shampoo to various parts of the hair coat. Rub to produce abundant lather. Add more water if necessary to increase lathering.

To kill fleas, ticks, and lice let lather remain in hair coat for five minutes. Work lather into outer ear if ticks are present. Rinse hair coat with clean water. Repeat as necessary.

STORAGE AND DISPOSAL

**Pesticide Storage:** Protect from freezing. Do not store near food or feed products. Store in an area inaccessible to children.

**Pesticide Disposal:** Securely wrap original container in several layers of newspaper and discard in trash.
