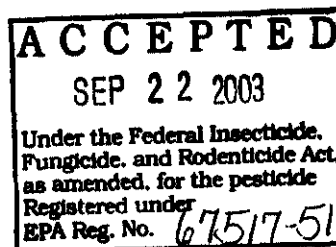

- If Swallowed**
- ° Call a poison control center or doctor immediately for treatment advice.

  - ° Do not give anything by mouth to an unconscious person.

- If Inhaled**
- ° Move person to fresh air.
  - ° If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably by mouth-to-mouth, if possible.

- ° Take off contaminated clothing.
  - ° Rinse Skin immediately with plenty of water for 15-20 minutes.

- ° Hold eye open and rinse slowly and gently with water for 15-20 minutes.
  - ° Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes.

Spray the animal from a distance of 8-12 inches. Start spraying at the tail, moving the dispenser rapidly and making sure the animal's entire body is covered, including the legs and under the body. Fluff the hair as you spray so the spray will penetrate to the skin. The spray should wet the ticks thoroughly. Do not spray in face, eyes or on genitalia. Repeat treatment as needed, but not more often than once every 7 days.

For cats apply at the rate of one second per pound of body weight. For dogs apply at the rate of 2 seconds per pound of body weight for thin or short-haired dogs and up to 8 seconds per pound of body weight for heavy or long-haired dogs.
