PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS & DOMESTIC ANIMALS

Shake well before use. Apply to dry surfaces only.

CARPETS:

- 1. Test on a hidden surface of carpet before use. If texture or color is affected,, do not use.
- 2. Shake powder evenly over carpet, pay particular attention to cracks and baseboards.
- 3. Work the dusts into the carpet by brushing lightly with a broom.
- 4. Wait 60 minutes. If ticks are present, wait 120 minutes.
- 5. Vacuum capet thoroughly.
- 6. Use every two weeks during the flea season.
- 7. Clean carpets after using this product.

FURNITURE:

- 1. Remove all loose cushions.
- 2. Sprinkle dust into creases and corners.
- 3. Gently brush dust in.
- 4. After 60 minutes, vacuum thoroughly
- 5. Do not use on exposed fabric, may cause staining

After vacuuming, dispose of vacuum cleaner bag by wrapping securely in several layers of newspaper and discard in trash.

Treat pets with a flea and tick control product approved for use on pets before reentry in treated area.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. Do not reuse this container.

Storage: Store in a cool, dry place out of reach of children or pets.

Disposal: Wrap container and put in trash. Do not reuse empty container.
