

Take care not to get the powder in animal's eyes, nose or mouth. Dust bedding, kennel and sleeping area regularly. Do not reapply product for 7 days. DO NOT USE ON DOGS UNDER 12 WEEKS OF AGE.

To control fleas, ticks and lice on cats and kittens, dust powder liberally over entire body. Rub dust into hair and around the feet, pads, and between toes so that they are well treated. Take care not to get the powder in animal's eyes, nose or mouth. Dust bedding, kennel and sleeping area regularly. Do not reapply product for 7 days. DO NOT USE ON KITTENS UNDER 12 WEEKS OF AGE.

STORAGE AND DISPOSAL

Storage: Store in original container in an area inaccessible to children and pets and away from heat and sunlight. Avoid exposure to moisture.

Disposal: Do not reuse empty container. Securely wrap original container in several layers of newspaper and discard in trash.
