PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS CAUTION

HAZARDS TO HUMANS:

Harmful if swallowed. Avoid contact with eyes, skin or clothing. Wash thoroughly with soap and water after handling. Groomers or other persons applying the product frequently must wear chemically resistant gloves.

HAZARDS TO DOMESTIC ANIMALS:

For external use only. Avoid contact with animals eyes and mouth. Do not use on puppies or kittens under 12 weeks of age. Do not use on sick, aged, medicated, pregnant or nursing animals without consulting a veterinarian. Following use, if you notice changes in your animals behavior or appearance, consult a veterinarian. It is advisable to consult a veterinarian before using this product with other pesticide or drug. Do not reapply product more often than once every 7 days.

If In Eyes: Flush eyes with plenty of water. Call a physician if irritation persists.

If Swallowed: Call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. If person is unconscious, do not give anything by mouth and do not induce vomiting.

ENVIRONMENTAL HAZARDS

This product is toxic to fish. Do not add directly to water. Do not contaminate water when disposing of equipment washwaters or rinsate.

DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling.

To prevent harm to you and your animal, read entire label then follow all directions and Precautionary Statements carefully.

Do not use on animals intended for food purposes. Do not get this product in your animals eyes or mouth. Wash hands and exposed skin thoroughly with soap and water after use.

Wet the animal thoroughly with lukewarm water. Apply a small amount of Insecticide Shampoo For Animals to various parts of the hair coat. Rub to produce abundant lather. Add more water if necessary to increase lathering.

To kill fleas, ticks, and lice let lather remain in hair coat for five minutes. Work lather into outer ear if ticks are present. Rinse hair coat with clean water. Do not reapply product more often than once every 7 days.
