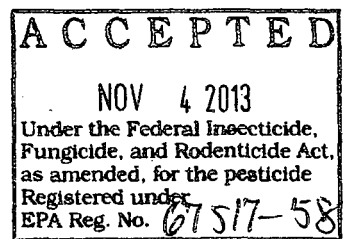

**ENVIRONMENTAL HAZARDS**
