



This product may only be used inside and within 50 feet of buildings or inside of transport vehicles (ships, trains, or aircraft). Do not sell this product in individual containers holding less than 4 pounds of bait. This product may be applied only by licensed pest control operators (PCO's).

SELECTION OF TREATMENT AREAS: Determine areas where rodents will most likely find and consume the bait. Generally, these are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been seen. Remove as much alternative food accessible to rodents as possible.

APPLICATION DIRECTIONS: The active ingredient in this product is different from anticoagulant rodenticides. Individual rodents cease feeding after consuming a toxic dose.

Mice: For typical placements, apply 1/4 to 1/2 ounce (7-14g) of bait per placement. Up to 3 ounces (85g) of bait may be needed in placements where heavy feeding is expected. Placements chould be spaced at 8 to 12 foot intervals.

DIRECTIONS FOR USE (CONTINUED)

Follow-Up: Adjust the amount of bait applied to the level of rodent feeding expected at each bait placement location. Highest bait consumption is expected to occur on the first day or two after treatment. After several days, inspect bait placements and replenish bait at sites where there is heavy feeding or where there is continued evidence of rodent activity. Maintain bait for at least one week and continue baiting until all signs of rodent activity have ceased or it becomes clear that the remaining rodents are not attracted to the bait.

Collect and properly dispose of all dead rodents and leftover bait. To discourage reinfestation, limit sources of rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE: Store only in original container in a cool, dry place inaccessible to children and pets. Keep containers closed and away from other chemicals.

PESTICIDE CONTAINER DISPOSAL: If Empty: Nonrefillable container. Do not reuse or refill this container. Dispose of empty container in a sanitary landfill, or by incineration, or, if allowed by state and local authorities, by burning. If burned stay out of smoke.
