On the basis of information furnished by the registrant, the above named pesticide is hereby registered/reregistered under the Federal Insecticide, Fungicide and Rodenticide Act. Registration is in no way to be construed as an endorsement or recommendation of this product by the Agency. In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. The acceptance of any name in connection with the registration of a product under this Act is not to be construed as giving the registrant a right to exclusive use of the name or to its use if it has been covered by others.

Based on your response to the Reregistration Eligibility Decision, EPA has reregistered the product listed above. 1. “**Professional (PCO) Use**”, located on the Master Label and Sublabel B, must be preceded by “*Intended for...*” so the statement reads “***Intended for Professional (PCO) Use***”.
2. Revise the “*EPA Reg. No.:61517-69*” located at the bottom of the Master Label to read “*EPA Reg. No.:67517-69*”.
3. On the front panel of sublabels A and B, immediately under the product name, add the statement “*This product may only be used inside and within 50 feet of buildings or inside of transport vehicles (ships, trains, or aircraft).*”
4. Revise “*Fast and Effective Indoor and Outdoor Rodent Control*” to read “*Effective Indoor and Outdoor House Mouse Control*” on sublabels A and B.
5. Revise the paragraph on page 1 to read “*House mice usually consume a toxic dose in a single night’s feeding but it may take two or more days...for them to die. Due to...anticoagulant-resistant mice.*”
6. Change your signal word from “**CAUTION**” to “**WARNING**” on sublabels A and B.
7. Change the statement on page 1 beginning with “***MAY BE HARMFUL IF EATEN...***” to read “***MAY BE FATAL IF EATEN BY CHILDREN OR PETS.***”
8. Add a bullet next to “*Remove contact lenses...then continue rinsing eye.*” within the **FIRST AID** box on sublabels A and B.
9. Revise the **PRECAUTIONARY STATEMENTS** as indicated on sublabels A and B:

**WARNING:** May be fatal if swallowed. Harmful if absorbed through the skin. Keep away from children, domestic animals, and pets. Causes moderate eye irritation. Do not get in eyes, on skin, or on clothing. All handlers (including applicators) must wear long-sleeved shirt, long pants, shoes plus socks, and chemical resistant gloves (such as or made out of any waterproof material, selection category A). Any person who retrieves carcasses or unused bait following application of this product must wear gloves.

For use only in non-food/non-feed areas.”*

**USE RESTRICTIONS:** *“Do not place near or inside ventilation duct openings. Do not contaminate water, food, feedstuffs, food or feed handling equipment, or milk or meat handling equipment or surfaces that come into direct contact with food. Do not use this product in sewers. Do not broadcast bait. This product may be applied only by licensed pest control operators (PCOs). Do not sell this product in individual containers holding less than 4 pounds of bait.”*

14. At the end of **“IMPORTANT”** and immediately before **“USE SITES”** on sublabels A and B, add: *“Note: Bait stations are mandatory for outdoor, above-ground use. Tamper-resistant bait stations must be used if children, pets, non-target mammals, or birds may access the bait.”*

15. Make the following revisions to the **SELECTION OF TREATMENT AREAS** section on sublabels A and B:

- a. Revise the first sentence to read "*Determine areas where mice will most...*"
- b. Revise the second sentence to read "*...or in locations where mice or their signs have been observed.*"

16. Make the following revisions to the **APPLICATION DIRECTIONS** section on sublabels A and B:

- a. Add "*in infested areas*" after "*...at 8 to 12 foot intervals.*"
- b. Revise "*Individual rodents...*" to read "*Individual mice...*"
- c. Revise "*Placements should...*" to read "*Space placements at 8 to 12 foot intervals.*"

17. Make the following revisions to the **Follow-Up** section on sublabels A and B:

- a. Replace "*rodent*" with "*mouse*" where ever it is mentioned.
- b. Replace "*rodents*" with "*mice*" where ever it is mentioned.
- c. Revise "*Collect and...*" to read "*Wearing gloves, collect...dead mice and leftover bait.*"

18. Revise the **STORAGE AND DISPOSAL** statement on sublabels A and B to read:

**STORAGE AND DISPOSAL**

Do not contaminate water, food, or feed by storage or disposal.

**PESTICIDE STORAGE:** Store only in a cool, dry place inaccessible to children and pets. Keep containers closed and away from other chemicals.

**PESTICIDE DISPOSAL:** Wastes resulting from the use of this product must be disposed of on site or at an approved waste disposal facility.

**CONTAINER HANDLING:** Nonrefillable container. These stations must be resistant to destruction by dogs and by children under six years of age, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. If bait can be shaken from stations when they are lifted, units must be secured or otherwise immobilized. Even stronger bait stations are needed in areas open to hooved livestock, raccoons, bears, or other potentially destructive animals, or in areas prone to vandalism.
3. Dispose of product container and unused, spoiled and unconsumed bait as specified on this label.

**USE SITES:** This product may be used to control House Mice inside and against outside walls of homes, industrial and agricultural buildings, and similar man-made structures. This product may also be used in alleys located in urban areas, inside transport vehicles (ships, trains, aircraft), and inside and against outside walls of related port or terminal buildings. For use in non-food/non-feed areas.

**USE RESTRICTIONS:** Do not place bait in areas where there is a possibility of contaminating food or surfaces that come in contact with food. Do not use this product in sewers. Do not place near or inside ventilation duct openings. Do not broadcast bait. Bait Stations are mandatory for outdoor, above-ground use. Tamper-resistant bait stations must be used if children, pets, non-target mammals, or birds may access the bait. This product may only be used inside and within 50 feet of buildings or inside of transport vehicles (ships, trains, or aircraft). Do not sell this product in individual containers holding less than 4 pounds of bait. This product may be applied only by licensed pest control operators (PCO's).

**SELECTION OF TREATMENT AREAS:** Determine areas where rodents will most likely find and consume the bait. Generally, these are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been seen. Remove as much alternative food accessible to rodents as possible.

**APPLICATION DIRECTIONS:** This active ingredient in this product is different from anticoagulant rodenticides. Individual rodents cease feeding after consuming a toxic dose.

**Mice:** Apply one place pack per placement. Space placements at 8 to 12 foot intervals.

**DIRECTIONS FOR USE (CONTINUED)**

**Follow-Up:** Adjust the amount of bait applied to the level of rodent feeding expected at each bait placement location. Highest bait consumption is expected to occur on the first day or two after treatment. After several days, inspect bait placements and replenish bait at sites where there is heavy feeding or where there is continued evidence of rodent activity. Maintain bait for at least one week and continue baiting until all signs of rodent activity have ceased or it becomes clear that the remaining rodents are not attracted to the bait.

Collect and properly dispose of all dead rodents and leftover bait. To discourage reinfestation, limit sources of rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.
