


Revise the statement "*For Use In and Around Agricultural Buildings and Industrial Sites Only*", located on sublabel A, to read "*This Product May Only be Used Inside and Within 50 Feet of Agricultural, Industrial, and Port or Terminal Buildings or Inside of Transport Vehicles (Ships, Trains, Aircraft)*"
2. Revise the "*EPA Reg. No.:61517-70*" located at the bottom of the Master Label to read "*EPA Reg. No.:67517-70*".
3. Revise "*Fast and Effective Indoor and Outdoor Rodent Control*" to read "*Effective Indoor and Outdoor House Mouse Control*" on sublabels A and B.
4. Revise the paragraph on page 1 to read "*House mice usually consume a lethal dose in a single night's feeding but it may take two or more days for them to die. Due to...anticoagulant-resistant mice.*"
5. Add a bullet next to "*Remove contact lenses...then continue rinsing eye.*" within the **FIRST AID** box on sublabels A and B.
6. Revise the **PRECAUTIONARY STATEMENTS** as indicated:

**CAUTION:** *Harmful if swallowed or absorbed through the skin. Causes moderate eye irritation. Keep away from children, domestic animals, and pets. Do not get in eyes, on skin, or on clothing. All handlers (including applicators) must wear long sleeve shirt and gloves. Any person who retrieves carcasses or unused bait following application of this product must wear gloves.*

For use in non-food/non-feed areas.

**USE RESTRICTIONS:** Do not place bait in areas where there is a possibility of contaminating food or surfaces that come in contact with food. Do not use this product in sewers. Do not place near or inside ventilation duct openings. Do not broadcast bait. Bait Stations are mandatory for outdoor, above-ground use. Tamper-resistant bait stations must be used if children, pets, non-target mammals, or birds may access the bait. This product may only be used inside and within 50 feet of buildings or inside of transport vehicles (ships, trains, or aircraft). Do not sell this product in individual containers holding less than 4 pounds of bait. This product may be applied only by licensed pest control operators (PCO's).

**SELECTION OF TREATMENT AREAS:** Determine areas where rodents will most likely find and consume the bait. Generally, these are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been seen. Remove as much alternative food accessible to rodents as possible.

**APPLICATION DIRECTIONS:** The active ingredient in this product is different from anticoagulant rodenticides. Individual rodents cease feeding after consuming a toxic dose.

**Mice:** Apply one place pack per placement. Space placements at 8 to 12 foot intervals.

**DIRECTIONS FOR USE (CONTINUED)**

**Follow-Up:** Adjust the amount of bait applied to the level of rodent feeding expected at each bait placement location. Highest bait consumption is expected to occur on the first day or two after treatment. After several days, inspect bait placements and replenish bait at sites where there is heavy feeding or where there is continued evidence of rodent activity. Maintain bait for at least one week and continue baiting until all signs of rodent activity have ceased or it becomes clear that the remaining rodents are not attracted to the bait.

Collect and properly dispose of all dead rodents and leftover bait. To discourage reinfestation, limit sources of rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.
