Revise the statement "For Use In and Around Agricultural Buildings and Industrial Sites Only", located on sublabel A, to read "This Product May Only be Used Inside and Within 50 Feet of Agricultural, Industrial, and Port or Terminal Buildings or Inside of Transport Vehicles (Ships, Trains, Aircraft)"

Generally, these are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been seen. Remove as much alternative food accessible to rodents as possible.

APPLICATION DIRECTIONS: The active ingredient in this product is different from anticoagulant rodenticides. Individual rodents cease feeding after consuming a toxic dose.

Rats: 3 to 8 place packs per bait placement. Placements should be spaced at 20 to 30 foot intervals.

Follow-Up: Adjust the amount of bait applied to the level of rodent feeding expected at each bait placement location. Highest bait consumption is expected to occur on the first day or two after treatment. After several days, inspect bait placements and replenish bait at sites where there is heavy feeding or where there is continued evidence of rodent activity. Maintain bait for at least one week and continue baiting until all signs of rodent activity have ceased or it becomes clear that the remaining rodents are not attracted to the bait.

DIRECTIONS FOR USE (CONTINUED)

Collect and properly dispose of all dead rodents and leftover bait. To discourage reinfestation, limit sources of rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.
