Purpose The purpose of your submission is to amend the label of your product in accordance with our July 17, 2002, letter.

Review of
labelThe labeling submitted with the above letter, under the Federal Insecticide,
Fungicide, and Rodenticide Act (FIFRA) is acceptable, provided that you make the
following label changes and submit one (1) copy of final printed labeling to us:

- 1. Give equal prominence to all subheadings in your use directions. Bold "USE RESTRICTIONS", "SELECTION OF TREATMENT AREAS", and "APPLICATION DIRECTIONS".
- 2. Retain the "IF SWALLOW" text of your label as <u>mandatory</u>. Because of the large number of oral incidents every year, the person handling the incident needs that information to obtain the advice and reassurance needed. A copy of the stamped label is enclosed for your records.
- 3. Modify house mouse directions as follows:

MICE: Apply one pack per placement. Space placements at intervals of 8 to 12 feet. Larger placements of up to 3 place packs ... mouse activity.

Do not use this product in sewers. Do not place bait in areas where there is a possibility of contaminating food or surfaces that come in direct contact with food. Do not broadcast placepacks or bait.

SELECTION OF TREATMENT AREAS: Determine areas where rodents will most likely find and consume the bait. Generally, these are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been seen. Protect bait from rain or snow. Remove as much alternative food accessible to rodents as possible.

APPLICATION DIRECTIONS: The active ingredient in this product is different from anticoagulant rodenticides. Individual rodents cease feeding after consuming a toxic dose.

Rats: Apply 2 to 8 placepacks per placement location. Space placements at intervals of 15 to 30 feet.

NOTE: ALL COMBINATIONS

Mice: Apply one pack per placement. Space placements at intervals of 8 to 12-feet. Larger placements of up to 4 place packs may be needed at points of extremely high mouse activity.

DIRECTIONS FOR USE (CONTINUED)

Rats and Mice: Adjust the amount of bait applied to the level of feeding by target rodents expected at each bait placement location. Highest bait consumption is expected to occur on the first day or two after treatment. After several days, inspect bait placements and replenish bait at sites where there is heavy feeding or where there is continued evidence of rodent activity. Maintain bait for at least one week and continue baiting until all signs of rodent activity have ceased or it becomes clear that the remaining rodents are not attracted to the bait.

Collect and properly dispose of all dead rodents and leftover bait. To discourage reinfestation, limit sources of rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.
