

1. Revise the statement "*For Use In and Around Agricultural Buildings and Industrial Sites Only*", located on sublabel A, to read "*This Product May Only be Used Inside and Within 50 Feet of Agricultural, Industrial, and Port or Terminal Buildings or Inside of Transport Vehicles (Ships, Trains, Aircraft)*"
2. Add an "A" after "67517-79" on the lower left-hand corner of pages 2-4 of sublabel A.
3. Add a "B" after "67517-79" on the lower left-hand corner of pages 2-4 of sublabel B.
4. Revise "*Fast and Effective Indoor and Outdoor Rodent Control*" to read "*Effective Indoor and Outdoor Rat and House Mouse Control*" on sublabels A and B.
5. Revise the paragraph on page 1 to read "*House mice, Norway Rats, and Roof Rats usually consume a lethal dose in a single night's feeding but it may take two or more days for them to die. Due to...anticoagulant-resistant mice and rats.*"
6. Add an eye statement to the **FIRST AID** box on sublabels A and B:

**If In Eyes:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing. Call a poison control center or doctor for treatment advice.

7. Revise the **PRECAUTIONARY STATEMENTS** as indicated:

**CAUTION:** Harmful if swallowed or absorbed through the skin. Keep away from children, domestic animals, and pets. Causes moderate eye irritation. Do not get in eyes, on skin, or on clothing. All handlers (including applicators) must wear long-sleeved shirt and gloves. Any person who retrieves carcasses or unused bait following application of this product must wear gloves.

**User Safety Requirements**

13. Make the following revisions to the **SELECTION OF TREATMENT AREAS** section on sublabels A and B:

- a. Revise the first sentence to read *"Determine areas where rats and mice will most..."*
- b. Revise the second sentence to read *"...or in locations where rats and mice or their signs have been observed."*

14. Make the following revisions to the **APPLICATION DIRECTIONS** section on sublabels A and B:

- a. Add *"in infested area..."* after *"per placement location."* in the **Rats** and **Mice** sections.

15. On page 4 of sublabel A, replace **"RATS AND MICE"** with **"Follow-Up"** as noted on sublabel B in this

16. Make the following revisions to the **Follow-Up** section on sublabels A and B:
- a. Replace "rodent" with "rat and mouse" where ever it is mentioned.
  - b. Replace "rodents" with "rats and mice" where ever it is mentioned.
  - c. Revise "Collect and..." to read "Wearing gloves, collect...dead rats and mice and leftover bait."
17. Revise the **STORAGE AND DISPOSAL** statement on sublabels A and B to read:

#### **STORAGE AND DISPOSAL**

Do not contaminate water, food, or feed by storage or disposal.

**PESTICIDE STORAGE:** Store only in a cool, dry place inaccessible to children and pets. Keep containers closed and away from other chemicals.

This product may also be used in alleys located in urban areas, inside transport vehicles (ships, trains, aircraft), and in and around related port or terminal buildings.

**USE RESTRICTIONS:** Do not use this product in sewers. Do not place bait in areas where there is a possibility of contaminating food or surfaces that come in contact with food. Do not broadcast place packs or bait. Bait Stations are mandatory for outdoor, above-ground use. Tamper-resistant bait stations must be used if children, pets, non-target mammals, or birds may access the bait. This product may only be used inside and within 50 feet of buildings or inside of transport vehicles (ships, trains, or aircraft). Do not sell this product in individual containers holding less than 4 pounds of bait. This product may be applied only by licensed pest control operators (PCO's).

**SELECTION OF TREATMENT AREAS:** Determine areas where rodents will most likely find and consume the bait. Generally, these are along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors and walls, or in locations where rodents or their signs have been seen. Protect bait from rain or snow. Remove as much alternative food accessible to rodents as possible.

**APPLICATION DIRECTIONS:** The active ingredient in this product is different from anticoagulant rodenticides. Individual rodents cease feeding after consuming a toxic dose.

**Rats:** Apply 2 to 8 place packs per placement location. Space placements at intervals of 15 to 30 feet.

**Mice:** Apply one place pack per placement. Space placements at intervals of 8 to 12 feet. Larger placements of up to 3 place packs may be needed at points of extremely high mouse activity.



**DIRECTIONS FOR USE (CONTINUED)**

**Follow-Up:** Adjust the amount of bait applied to the level of rodent feeding expected at each bait placement location. Highest bait consumption is expected to occur on the first day or two after treatment. After several days, inspect bait placements and replenish bait at sites where there is heavy feeding or where there is continued evidence of rodent activity. Maintain bait for at least one week and continue baiting until all signs of rodent activity have ceased or it becomes clear that the remaining rodents are not attracted to the bait.

Collect and properly dispose of all dead rodents and leftover bait. To discourage reinfestation, limit sources of rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations and replenish as needed.
